**FILING GUIDELINES FOR DIRECT CITES;
DIRECT CITATION LIST;
ADMINISTRATIVE CITATION ENFORCEMENT (ACE) LIST**

Policy Summary:

- Identifies offenses that are deemed to be infractions and handled via direct cite;
- Requires that every offense must contain a narrative for misdemeanor consideration;
- Absent limited exceptions, prohibits filing a VC §14601.1(a) if the underlying license suspension/revocation is solely due to a FTA on an unpaid traffic citation;
- Identifies LAMC violations to be handled via ACE citation.

Note: This is only a summary of, and not a substitute for, the below policy.

INTRODUCTION

This memo sets forth the guidelines for filing criminal cases pertaining to specified crimes that may be filed as misdemeanor or infraction offenses, commonly referred to as "wobblettes." These guidelines are effective on January 1, 2024, and supersedes all previously issued policies, protocols, and lists related to direct citations and administrative citations. These are filing guidelines only. Prosecutors retain the discretion to deviate from these guidelines, when appropriate, given the facts of a particular case along with any mitigating or aggravating circumstances.

I. DIRECT CITATIONS

All violations on the Direct Citation List, included herein as Attachment #1, that are cited on a written notice to appear ***without an accompanying narrative*** shall be deemed to be infractions pursuant to Penal Code Section 17(d) and Los Angeles Municipal Code Section 11.00(m).

If a law enforcement agency seeks to have one of these "wobblettes" prosecuted as a misdemeanor, the law enforcement agency shall utilize the existing arrest and booking process, complaint application process, ***or the Notice To Appear/RFC short form arrest report 5.02.08*** with a narrative containing sufficient information to support the charge (this shall include misdemeanor violations of Vehicle Code (V.C.) section 14601.1(a)).

The Notice to Appear/RFC short form arrest report is not permissible without valid identification. Officers should also include a brief statement of the

reason that the charge should be prosecuted as a misdemeanor. Such reasons might include, but are not limited to, where the violation is part of an ongoing nuisance, or where the suspect has a criminal history, or where there is a likelihood the offense will continue, or any other aggravating factor the officer feels warrants a misdemeanor filing.

A. VEHICLE CODE § 14601.1(a) VIOLATIONS

If a law enforcement agency is seeking misdemeanor review for a **V.C. 14601.1(a)** violation, that agency should consider prior vehicle code convictions, license suspensions and/or revocations and the offender's overall driving history in justifying misdemeanor review. Additionally, the law enforcement agency shall verify that the violator has "A", "M" or "J" service for the license suspension and/or revocation. A list of DMV SERVICE CODES is set forth below.

DMV SERVICE CODES

A misdemeanor charge for a V.C. §14601.1(a) violation shall **not** be filed if the underlying license suspension/revocation is solely due to a failure to appear on an unpaid traffic citation. Assembly Bill 103 repealed the Los Angeles County Superior Court's authority to initiate driver's license suspension with the Department of Motor Vehicles when an individual fails to pay a fine on a traffic violation; however, the court retains authority to initiate suspension or hold actions when an individual fails to appear. Notwithstanding, an exception may be made if V.C. 14601.1(a) is a lesser charge on a misdemeanor criminal complaint, the defendant was involved in an accident, or the defendant is on probation. Additionally, the agency is not precluded from seeking misdemeanor review for a V.C. 14601.1(a) charge if the underlying suspension/revocation is due to unpaid child support, an accident, reckless driving, or some other safety reason or compelling government interest.

II. ADMINISTRATIVE CITATION ENFORCEMENT PROGRAM

While law enforcement agencies have the authority to issue direct citations or seek misdemeanor review for violations of the Los Angeles Municipal Code (LAMC), it is strongly encouraged that, if circumstances warrant, law enforcement agencies utilize the Administrative Citation Enforcement (ACE) program as an alternative means to enforce violations. ACE violations and the issuance of ACE citations are limited to specified LAMC sections only. Those specified violations are contained in the ACE Master List and attached hereto as Attachment #2. If a particular LAMC section is not included on the ACE Master List, those violations may be processed as a direct cite or, if appropriate, a misdemeanor referral.
