LAPD BOPC, Chief, Mayor Bass and the entire LAPD and Public,

During the last meeting of the Police Commission which was held on August 20. I patiently waited with my hand held up on Zoom to be called on to allow me speak publicly. The meeting was again disrupted by the usual suspect who blatantly shows no regard for the rules of the meeting such as time limits and the rights of others who wish to speak in violation of 403 PC Disrupting a Public meeting. The failure of the Police Commission with the Chief of Police, Sgt at Arms and numerous officers present is a disgrace and sets a very bad example for everyone in the LAPD, our city, nation, and world.

When the room was cleared due to the disruption by the usual suspect, public comment resumed. I waited patient for my name to be called and confirmed that my virtual hand was raised to be called on.

At the 55:38 minute mark the secretary who calls upon the next speak announced, " We have no other speakers in the public". That was just not accurate or true because I was waiting to be called upon. Why was I denied my opportunity to speak in public comment? Was it human error. a glitch in the system, censorship? I was greatly disappointed at that turn of events and I bring it your attention so that the same occurrence does not repeat itself. As I recall, the Police Commission is committed to allowing all who attend in person or on zoom to be heard. Please honor that commitment or publicly rescind it.

Bringing us up to date, allow me to address a few issues. One of the LAPD Core values is "Integrity in All We Say and Do". Is this just a high sounding ideal for show or is this core value taken seriously? I ask because its apparent that Commander Lillian Carranza and her paramour Deputy Chief Marc Reina colluded and misrepresented their rank so that they could participate in a survey ranking Command Staff. The Police Union directors and attorneys presented the facts of the situation very clearly and concisely!

Is misrepresenting yourself in a an electronic survey not an integrity issue? What other things have these two done which demonstrates a lack of integrity that we are not able to see. Their lack of integrity and poor judgement demand that action be taken and the first action should

be that they are relieved of duty pending the investigation and legal action pending. This is a serious breach of trust that the public has become aware of and action must be taken to restore that trust. There cannot be one standard for the Command Staff and one for the members of the Police Union who range in rank from police officers, Sergeants, Detectives, and Lieutenants. Double standards destroy morale and since this issue has come to your attention and the attention of the public there must be a focus on this long standing issue of double standards within the LAPD!
