
**SUBJECT:** APPROVED HOME-GARAGING AUTHORITIES - FISCAL YEAR 2022/23

At a regular meeting of the Board of Police Commissioners (BOPC) held on December 13, 2022, the attached list of Home-Garaging Authorities (HGA) was approved for Fiscal Year (FY) 2022/23, which began on July 1, 2022.

The Home-Garaging Employee Authorization (HGEA), Form 11.35.01, is a contract in which an employee and his/her commanding officer certify that the employee is assigned to a position or to a function for which the given HGA has been approved by the BOPC. Each employee who uses an HGA must hold a valid HGEA prior to such use. Any change in garaging location or other condition of use invalidates the concerned HGEA. A new HGEA identifying the change must be completed, approved and forwarded to Administrative Services Bureau (ASB) via the employee's chain of command. The HGEA, Form 11.35.01, may be downloaded via the Department Local Area Network at <http://pdfforms.lapd.lacity.org/Forms/>.

When a single HGA is assigned to a position or to a function that is shared amongst several personnel, only one employee per HGA may home-garage at any one time. Employees who have approved HGAs based on the requirement to respond off-hours to incidents of an emergency nature are authorized to use the HGA only when they are assigned to the off-hour response duties. All existing home-garaging procedures in Department Manual Section 3/260 are valid and should be referred to for further information.
