On November 2, 2025, the Los Angeles Police Department was tasked with keeping the peace, protecting life and property, and ensuring overall public safety during celebrations following the Los Angeles Dodgers' World Series victory. A large crowd gathered in Down Town Los Angeles, near Olympic Boulevard and Grand Avenue. The crowd unlawfully entered the roadway, obstructed traffic, and used commercial-grade fireworks/explosive devices. Approximately 500 people became unruly and began throwing rocks, bottles, and other large projectiles at officers. This behavior posed a fire hazard and created a significant risk of serious bodily injury to officers and bystanders. Commander Raul Jovel, Serial No. 33400, Central Bureau Assistant Commanding Officer, served as the Incident Commander. He assessed the situation, declared the gathering an unlawful assembly, and directed a dispersal order be given. Despite this order, the crowd continued to grow, eventually reaching approximately 1,000 people. As the situation escalated and members of the crowd became more hostile, engaging officers in physical altercations while launching industrial-grade fireworks and additional projectiles, Commander Jovel authorized the use of kinetic energy and chemical agents to regain control and disperse the riotous crowd.
