SUBJECT: MAY 2025 NATIONAL POLICE WEEK PARTICIPANT SUBMISSIONS

The Department is seeking full-duty, sworn personnel to participate in the Los Angeles Police Department (LAPD) Honor Platoon and National Police Week (NPW) activities to be held in Sacramento, CA, May 5 to 7, 2025, and Washington, D.C., May 11 to 16, 2025.

Sworn personnel interested in participating in the LAPD Honor Platoon and National Police Week events must first obtain written approval from their commanding officer and must be full-duty status at the time of the event. To be considered for these details, please submit an Employee's Report (Form 15.07.00) to your commanding officer. This report should include your expression of interest, qualifications, commitment to purchase any required items, and agreement to adhere to the Honor Platoon's Rules and Protocols.

Please note the following details:

- Lodging and airfare will be provided. Meals will not be included, though a hotel with a complimentary breakfast may be selected as the host hotel; this is yet to be determined and is not guaranteed.
- This is a voluntary detail; therefore, per diem and overtime will not be authorized.
- Commanding officers must record the duty status of selected personnel as Leave with Pay (LP) for the specified duration: three days for Sacramento and five days for Washington, D.C.
- Selected personnel must attend a briefing (duty status: E4 – 3 hours) at the Los Angeles Police Protective League on April 8, 2025, at 1100 hours.

Commanding officers are requested to forward the original, approved Employee's Reports to Commander Steve Embrich, Serial No. 30993, Commanding Officer, Support Services Group, LAPD National Police Week Coordinator.

This detail can be physically demanding and requires sworn personnel to walk and stand for long periods, possibly in inclement weather. Sworn personnel will be required to own a Department-approved Blauer 4660 Softshell Duty jacket in excellent condition, with Department specified name tape, proper rank insignia, and an embroidered badge with corresponding rank and badge number as defined in the Uniform and Equipment Committee Notice, *Department Approved Jackets*, dated December 20, 2017. In addition, participants must have an approved air travel firearms lock box and lock and appropriate business casual attire.

The LAPD Honor Platoon, Sacramento, CA, is expected to participate in the following uniformed events: Candlelight Vigil at the California State Capital and the California Peace Officers' Memorial Foundation Enrollment Ceremony.

The LAPD Honor Platoon is scheduled to participate in several uniformed events in Washington, D.C. These events include:

- Candlelight Vigil at the National Mall;
- Arlington National Cemetery;
- National Law Enforcement Officers Memorial; and,
- United States Capitol.

Personnel will also be required to stand in formation during these events. Each participant shall ensure their uniform appearance (class "A" with cover) is in excellent condition.

Classmates, former partners, relatives, and/or close friends of an officer killed in the line of duty shall receive preference for selection. Sworn personnel with prior military service, especially those who have been deployed overseas, are encouraged to apply. Preference may also be granted to those individuals who have not previously participated in this detail. Approved paperwork must be received by Commander Embrich no later than December 30, 2024.
