SUBJECT: EMERGENCY AIR TRANSPORTATION PLAN – REVISED

The annual audit of the Emergency Air Transportation Plan (EATP) has been completed and has resulted in minor revisions. The revisions consist of the following:

- The Essential City Personnel list has been updated.
- The Regional Emergency Landing Sites and alternate facilities have been updated.
- The Emergency Radio Access has been updated.


Supervisors shall ensure that the revised “*Response Protocols – Emergency Air Transportation Plan*” be placed inside the current Divisional Standing Plans (Section IV Mobilization). It also can be found in Volume 10 of the Emergency Operations Guide (EOG). The EOG should be used as a reference guide in the event of a major incident requiring air transport for essential City personnel.

RESPONSE PROTOCOLS EMERGENCY AIR TRANSPORTATION PLAN

The Emergency Air Transportation Plan (EATP) Coordinator will establish the EATP and cause notification to the Chief of Police and the Fire Chief or their designee as soon as possible following activation. The EATP Coordinator will direct City air assets to begin flying EATP missions to the **four Regional Emergency Landing Sites per the Rendezvous Matrix (below).** **An additional air asset will be utilized to respond to alternate landing sites as necessary in accordance with the EATP.** The Rendezvous Matrix illustrates the time frames that air assets will attempt to make contact at the four regional landing zones. Personnel who have been identified as “Essential City Personnel” shall respond to the regional landing sites per the Rendezvous Matrix. The Rendezvous Matrix has been designed to meet potential flight times of air assets. Personnel awaiting the arrival of an air asset must be vigilant in adhering to the matrix.

*****NOTE: If air assets do not arrive during the indicated time, return to the pickup site at the next scheduled rendezvous time and continue the process until contact with an air asset or the EATP Coordinator has been achieved.*****

In most cases, City air assets can only accommodate two passengers. The EATP Coordinator will decide the order in which Essential City Personnel will be transported if more than two people are awaiting transport at the same pickup site.

RENDEZVOUS MATRIX

Rendezvous Time	Standby Time
2400 hours	Remain at site until 0200 hours
0400 hours	Remain at site until 0600 hours
0800 hours	Remain at site until 1000 hours
1200 hours	Remain at site until 1400 hours
1600 hours	Remain at site until 1800 hours
2000 hours	Remain at site until 2200 hours

“Essential City Personnel” utilizing the EATP are reminded to bring only those personal care items to sustain themselves for a minimum of three days. All helicopters will vary in weight and balance performance, thus limiting the number of passengers and luggage per aircraft.

EMERGENCY RADIO ACCESS

When all usual communications capabilities are impaired, it may *still* be possible to access radio systems during such incidents. The following radio protocols should be attempted sequentially during incidents where a total communications failure has occurred in order to utilize Police/Fire

Department radios to access Mutual Aid Channels and hail the EATP Coordinator or any City helicopter who will relay the message to the EATP Coordinator.

Direct / Simplex Mode on LAPD Divisional Fallback Channels and Tactical Channels

Department personnel may be able to communicate using handheld and mobile radios in Direct / Simplex mode on any LAPD Divisional Fallback Channel or tactical channel. On the newly issued LAPD APX-8000 Departmental Simplex Channels are located in Zone-26 Channels 101 through 125. These channels DO NOT require the manipulation of the "A B C Toggle" as these channels are pre-programmed in DIRECT / SIMPLEX Mode. To utilize the "FALLBACK" Channels, use Zone-26 Channels 301 through 325. These channels are pre-programmed in the "REPEATER / DUPLEX" mode and DO NOT require the manipulation of the "A B C Toggle."

***** NOTE: To utilize Direct / Simplex mode on Department issued Motorola XTS-5000 handheld radios, first select a Divisional Fallback Channel or tactical channel then place the "A B C" toggle switch in position "B". When using a Department mobile radio, select a Divisional Fallback Channel or Tactical channel then press the "DIR" button. These communications are limited to line of sight and only radios tuned to the same Fallback Channel or tactical channel can receive/return broadcasts. *****

Local Mutual Aid Channels

Mutual Aid Channels may be utilized if they are available. The Los Angeles County Sheriff's Department (LASD) maintains several channels that are currently programmed into the Los Angeles Police Department (LAPD) radios. These channels are part of the Los Angeles Regional Tactical Communications System (LARTCS) managed by the Los Angeles County Sheriff's Department. The LARTCS provides direct communication interoperability between law enforcement, fire, emergency medical services, Federal, State and military agencies at the scene of a major, multi-agency incident. These incidents may be short term (felony pursuits through multiple jurisdictions, fires, hazardous materials, etc.) or long term (large-scale fires or floods, civil disturbances, terrorist incidents, etc.). Safety of the on-scene personnel involved in these incidents will be enhanced through real-time, unit-to-unit communication. The LARTCS channels are available to any public safety agency within Los Angeles County or the surrounding counties. Keep in mind that during a disaster, these channels may be utilized by other agencies.

To utilize these channels, a request must be made to the LASD Communications Center at (323) 881-8100. During an emergency or disaster, and when a telephone cannot be utilized to contact the LASD Communications Center, turn the LAPD Radio to Zone-26 Channel 80. This is the LASD Access Channel. This channel is available to all outside agencies.

- LARTCS MA/1 – ZONE-26 / CHANNEL 81
- LARTCS MA/2 – ZONE-26 / CHANNEL 82
- LARTCS MA/3 – ZONE-26 / CHANNEL 83
- LARTCS MA/4 – ZONE-26 / CHANNEL 84
- LARTCS MA/5 – ZONE-26 / CHANNEL 85

*****NOTE: In addition to being the access channel, it is also the primary dispatch channel for the LASD Parks Bureau. Mutual Aid Channels operate via a repeater system, have a greater range and should be utilized first. *****

Nationwide Mutual Aid Channels

The LAPD is authorized to use several Non-Federal National Interoperability Channels. The U-Call channel is a shared national calling channel, and the U-Tac channels are shared national tactical channels. These channels are for multi-agency responses similar to Fire Ground and Mutual Aid channels. The U-Call and U-Tac channels will allow interoperability between all agencies that have these frequencies in their radios. These channels are shared, and may be utilized by other surrounding agencies, and should only be utilized as a last resort.

- U-CALL-40 ZONE-26 / CHANNEL 69 (Simplex / Direct Mode)
- U-TAC-41 ZONE-26 / CHANNEL 70 (Simplex / Direct Mode)
- U-TAC-42 ZONE-26 / CHANNEL 71 (Simplex / Direct Mode)
- U-TAC-43 ZONE-26 / CHANNEL 72 (Simplex / Direct Mode)

*****NOTE: The U-CALL and U-TAC UHF channels should only be used in Direct / Simplex Mode. This allows direct line of sight communication only.*****

AIR CREW RESPONSIBILITIES – LAPD/LAFD

- Staff air resources with personnel to complete missions – LAPD/LAFD
- Flight crew will manage landing zones from the air - LAPD
- Provide instruction to prospective passengers on air safety – LAPD / LAFD
- Verify “Essential City Personnel” authorization to EATP - LAPD
- Transport “Essential City Personnel” to designated locations – LAPD/LAFD
- Communicate all EATP transports with EATP Coordinator – LAPD/LAFD
- Five air assets will be assigned to fly the EATP missions as directed.
 - Four air assets will respond to Primary Regional Emergency Landing Sites.
 - One air asset will be tasked with responding to all other EATP locations.
- Helicopter Landing Zone Protocols shall be followed.

*****NOTE: The updated “Essential City Personnel” list will be provided semiannually to all air crews for inclusion in their aviation plans.*****

ESSENTIAL CITY PERSONNEL RESPONSIBILITIES

In the event of partial communications failure, “Essential City Personnel” shall attempt to initiate contact with the EATP Coordinator through one of the means listed below:

- Call Air Support Division (ASD) Watch Commander at (213) 485-2600, or ASD administrative office at (213) 473-8184, during regular business hours;
- Radio – Police/Fire Department Radio to **Zone-26** Channel 43 – Citywide Tac-1;
- If **Zone-26** Channel 43, Citywide Tac-1 is unavailable, utilize the Emergency Radio as outlined above;
- Utilize Emergency Communication Protocols;
- Send an email to DOC@lapd.online; or,
- Provide current location information to EATP Coordinator.

With any level of communications failure:

- Respond to the nearest regional Emergency Landing Site per the Rendezvous Matrix (see Page 1 of 9);
- If unable to respond to one of the four Regional Emergency Landing Sites, respond to the nearest police station and advise the watch commander that you are on the “Essential City Personnel” list;
- Prepare for rendezvous with air asset and follow directions of ground/flight crew personnel at the landing site;
- If no ground crew is present at the landing site, conduct a visual site survey of the landing area where the helicopter is likely to land. Check for obstructions or items that could interfere with the landing of the aircraft. When possible, clear the obstructions from the landing area. The pilot of the aircraft will survey the area prior to landing and will land in an area determined to be the safest; and,
- Approach aircraft with extreme caution.
 - Always follow directions of the ground/flight crew;
 - If no ground crew, remain at least 300 feet away from the aircraft until the pilot/crew from the aircraft provide direction to approach;
 - Always approach aircraft from the front of aircraft;
 - Approach with caution and be alert for moving parts that may not be visible;
 - Board the aircraft ONLY when directed by the flight crew; and,
 - Once boarded be guided by all instructions from the flight crew.

WATCH COMMANDER RESPONSIBILITIES

The “Essential City Personnel” list will be compiled and updated by the Emergency Management Department (EMD). The EMD will disseminate the updated list to the LAPD, Department Operations Center (DOC) and all City Heads of Departments. The DOC will distribute the updated list to all Watch Commanders immediately upon receipt from EMD. Watch Commanders will place the updated “Essential City Personnel” list in the Area Standing Plans.

- Verify the individual requesting emergency air transportation is listed on the “Essential City Personnel” list;
- Upon verification, assign personnel to contact air assets that are within line of sight of the police station using ROVERS;
- Advise the air asset that an authorized EATP user is standing by at the police facility for emergency air transport;
- Obtain a time and location where the EATP air asset will rendezvous with the “Essential City Personnel”;
- Assign personnel to transport and assist the “Essential City Personnel” to rendezvous with the air asset;
- Assist ground/flight crews as necessary to facilitate the safe landing and takeoff of the air asset. It may be necessary to close off a City street, park, or large parking lot to facilitate the landing of an air asset, and assign personnel as needed; and,
- Document the EATP activity and forward to the Department EATP Coordinator, C/O, ASD.

****NOTE: It is imperative that only those personnel who have been designated as “Essential City Personnel” gain access to emergency air transportation in compliance with the EATP. City Heads of Departments delegate authority to each flight crew to deny access to any person, regardless of rank or position, who is not listed on the “Essential City Personnel” list.****

Request the watch commander to contact the EATP Coordinator per procedures listed previously.****
