SUBJECT: MODIFICATION OF MISDEMEANOR RELEASE FROM CUSTODY (RFC)
CITEBACK DATES FOR COURT DUE TO COVID-19 PANDEMIC

The Los Angeles Superior Court has instituted modified hours of operations to reduce the likelihood of the spread of COVID-19. As a result of these modified hours, many non-essential court appearances are being postponed to a later date. These non-essential court appearances include those resulting from the issuance of misdemeanor Release from Custody (RFC) citations.

Effective immediately, and until further notice, personnel shall use the Los Angeles Superior Court's "Court Date Calculator" to determine a citeback date that is 65 court days from the date of RFC issuance. The Court's calculator can be found at: <https://www.lacourt.org/courtdatecalculator/ui/>
