Annual Complaint Report 2018

This summary of complaints includes information on the source of complaints, types of allegations received, the disposition of those allegations and the resulting discipline.

The data on this page provides information about the number and source of complaints based on complaints initiated in 2018 and provides a comparison of complaints initiated in 2018 against prior years. The data on the remaining pages is based solely on closed complaints. For closed complaints, data such as final allegation type and complaint disposition are presented along with comparisons with prior years. Because complaints closed in one year may have been initiated in a prior year, the data does not necessarily depict any pattern or trends regarding employee conduct in any particular year.
