SUBJECT: EMAILING OF VEHICULAR PURSUIT RECORDINGS

To increase efficiency in the dissemination of pursuit audio recordings to investigating personnel, Communications Division will begin emailing audio files of recorded pursuits and associated incident printouts.

Commanding Officers shall designate employees from the Divisional Training Cadre to access and distribute the emailed audio recording links as needed. Training Coordinators shall assume responsibility for dissemination of the emailed links from the Communications Division Projects Unit SharePoint database to the appropriate personnel. The emailed vehicle pursuit recordings shall not be disseminated, copied or used for any other reason other than for official Department use and completion of the necessary reports.

Attached are the email access instructions and a list of current Divisional Training Coordinators with proxy rights. The email addresses will allow Divisional Training Coordinators to maintain accountability and distribution of pursuit audio recordings within their chain of command. Personnel with email proxy rights shall be verified by each Command. Changes of personnel with email proxy rights shall be reported to Information Technology Division by creating a work ticket via the "Computer HelpDesk" application.

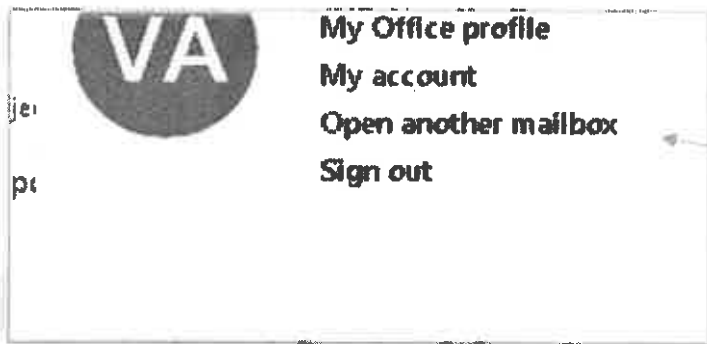

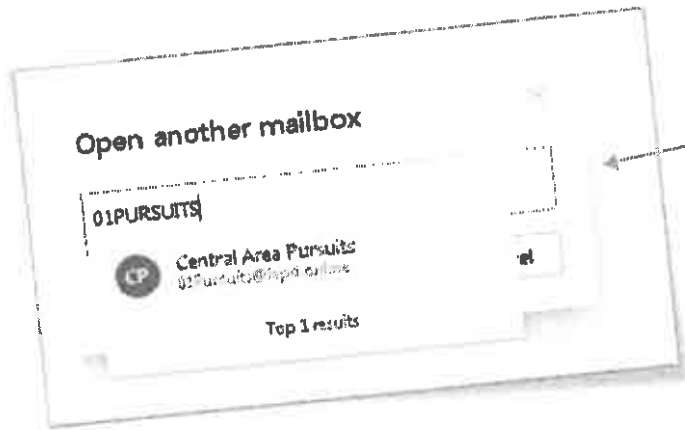
