**SUBJECT:** INSPECTION OF DEPARTMENT MOBILE FIELD FORCE KITS -  
SEPTEMBER 20, 21 AND 22, 2016

An inspection of the Department's Mobile Field Force (MFF) Kits will be conducted on September 20, 21 and 22, 2016, at the Edward M. Davis Training Facility, 12001 Blucher Avenue, Granada Hills. The inspection will begin promptly at 0700 hours in the north parking lot adjacent to Range C. Assigned personnel shall be responsible for bringing their MFF Kits and related equipment in their designated MFF vehicles as they will also be inspected. Concerned commanding officers shall direct their Emergency Preparedness Coordinators to participate as scheduled, along with personnel tasked with the responsibility of maintaining and deploying MFF Kits. Attached is the schedule of Bureaus, Areas, and specialized entities to be inspected.

The inspection will be conducted by personnel from Emergency Operations Division (EOD), charged with Department-wide coordination and oversight of the MFF Kits. In addition, personnel from Training Division will participate by inspecting weapons and ammunition contained in the MFF Kits. New equipment will be issued as required. The inspection will assist Department entities by reviewing maintenance/storage requirements, as well as the policy for deploying MFF Kits during unusual occurrences. The biannual inspections are mandated to ensure adherence to established Department policy, procedures and rules.
