SUBJECT: CALIFORNIA DEPARTMENT OF MOTOR VEHICLES UNDER AGE 21
OFFICER'S STATEMENT DS 367M FORM (REV 1/2015) – REVISED

PURPOSE

The purpose of this Notice is to advise that the use of the Department of Motor Vehicles (DMV) "Under Age 21 Officer's Statement," Form DS 367M (Rev 1/2015), shall be discontinued. It was discovered that there was a printing error on the form, which omitted the penalty of perjury statement. Effectively immediately, all existing DS 367M (Rev 1/2015) forms should be discarded.

PROCEDURE

The DMV has revised the "Under Age 21 Officer's Statement," Form DS 367M (Rev 5/2016), to include the perjury statement. These new forms are currently available and may be ordered through Supply Section, Fiscal Operations Division.
