When police are seen as legitimate, people will voluntarily comply with the law.</p> <p>C. Research has shown that citizens' demeanor is often influenced by police officer's behaviors towards them-Aggressive</p>	<p>Collect: Completed arrest report assigned in prior class. Instructor will review and make necessary correction and return to recruits to see their progress.</p> <p>Go over the Arrest Domestic Violence exemplar with the class. Answer questions and clarify.</p> <p>[Note] Evaluate the scenario with the class. Take the back to that day and go over how the Officers handle the arrest.
