  - a. Find any restraining orders (CARPOS)

- I. California Law Enforcement Telecommunication System (CLETS)
  - A. System Log-on
    - 1. **Learning Activity:** Students will log onto NECS
      - a. Select the NECS icon on the desktop
      - b. The Enterprise Server screen will display
        - 1) Type **NECS**
        - 2) Press **ENTER**
    - 2. **Learning Activity:** New users set a password
      - a. Signon: Student's serial number. (The cursor will automatically default to the "Password" field)
      - b. Password: **TRNG**
      - c. New Password: Enter an eight (8) character alpha-numeric password. No special characters
      - d. Press **ENTER**
      - e. Re-enter password
      - f. Press **ENTER**.
    - 3. If the sign-on is successful, the Command Screen will display.
    - 4. **Learning Activity:** Students will log in again using the password they created
      - a. Type LOGOFF on the command line to return to the beginning
      - b. Type NECS in the appropriate area

- a. ESC key—Removes the error message
  - b. TAB key—Moves cursor to the right and places it in the correct position to begin typing.
2. No Msgs. Waiting—message queue
- a. Holds messages waiting to be read

  - c. Select the PF15 button to remove messages before making inquiries
  - d. First message into the message queue will be the first one removed from the queue.
3. Virtual keypad displays at the bottom or top of screen
4. Other function keys
- a. PF20—Go to the next page in a response (i.e. 1,2,3,4, etc.)
  - b. PF19—Return to the previous page in a response (i.e. 4,3,2,1)

        - (a) Date and time WIS was requested

        - (c) REC TYPE: Warrant; CATEGORY: Bench; LEVEL: Felony.
        - (d) Name, physical descriptors, scars-marks-tattoos, subject's home and business addresses and phone numbers.
        - (e) FBI Number: Subject has criminal history outside of California.

          - i. "A" means rap sheet is automated (on the computer)
          - ii. "M" means rap sheet is manual (hard copy) and must be obtained from the California Department of Justice.
          - iii. "H" means rap sheet is a hybrid with some automated, some manual.
          - iv. All numbers (123456789) means the rap sheet is not connected to fingerprint (i.e. pushing a shopping cart, drinking in public.
      - (2) Advise students the WIS may return to the system if the subject is not booked within 2 hours.

          - i. ARR/DET/CITE: Arrested, detained, cited
          - ii. NAM#: Name suspect used during this incident (see page 4 for list of AKAs)

  - (2) How long will the sex offender records stay in the system

    - (1) Additional CII numbers (pg. 1) indicate changes in the fingerprints before bookings.
      - (a) CII numbers are tied to a person's fingerprints
        - Missing left finger (pg. 5)
      - (b) Drug possession, sales, or use could have caused damage of fingerprints through accidental burning. (Pgs. 7, 22, and 23)
      - (c) Diversion (Pg. 7) indicates person went to a drug rehabilitation center rather than jail.
    - (2) Applicant information (Pgs. 24 and 28)
      - (a) Remind students fingerprints create a CII number
      - (b) They have rap sheets due to the fingerprinting process when they applied for LAPD.
    - (3) What significance is the surgical sex change notation?
      - (a) Suspect must be separated from general population when housed.
      - (b) Searches
