SUBJECT: APPROVED UNIFORM AND EQUIPMENT ITEMS - NOVEMBER 2019

The Uniform and Equipment Committee (UEC), and the Chief of Police, have approved the following uniform and equipment items:

#### 1. APPROVAL OF THE PACIFIC AREA PIN

Pacific Area has designed a divisional pin for wear on the Department approved uniform.

The design of the pin depicts a shield outline with an anchor and rope in the center. The silver and gold base metal pin reflects the number "14" gold in color to represent the division's numerical designation. The background is blue and black in color. The dimensions are in accordance to Department Manual Section 3/639.

## 2. APPROVAL OF THE PIN FOR CENTRAL AREA SPECIAL PROBLEMS ENFORCEMENT UNIT (SPEU)

Central Area Special Problems Enforcement Unit (SPEU) has designed a pin for wear on the Department approved uniform. The Department has approved the wearing of this pin for personnel assigned to this unit.

The pin is silver base metal, rectangular in shape with a black outlined silhouette depicting the iconic Los Angeles Downtown City at the top. The pin reflects the number "01" in silver with a black outline which represents the Central Division numerical designation. The bottom of the pin has the letters "SPEU" in black with a silver outline, which is the acronym for the Special Problems Enforcement Unit. The dimensions are in accordance to Department Manual Section 3/639.

### 3. APPROVAL OF THE RECRUITMENT AND EMPLOYMENT DIVISION (RED) PIN

Recruitment and Employment Division (RED) has designed a pin for wear on the Department approved uniform.

The divisional pin will distinguish the personnel who are assigned to RED. The pin is silver base metal depicting the word "RED" in capital letters. The dimensions are in accordance to Department Manual Section 3/639.

### 4. APPROVAL OF THE TRAFFIC GROUP (TRFG) LOGO

Traffic Group (TRFG) was established under the recent reorganization of the Department.

Therefore, TRFG has created a new Group logo which will be used on items such as, but not limited to, polo shirts (non-uniform), hats and/or challenge coin. The logo is black and silver in color. It consists of a shield, an arrow, a wheel and wings. The arrow represents the Department Police Motorcycle force. The wings represent the Department Collision Investigators and the wheels represents both. The shield represents the integrity of the Department.

# 5. APPROVAL OF THE COMMUNITY RELATIONS SECTION (CRS) LOGO AND PLAIN CLOTHES ALTERNATIVE TO UNIFORM

Community Relations Section (CRS), created a logo for use by CRS personnel. This logo will be used on, but not limited to, a collared button down black dress shirt with no breast pockets. The patch logo is 3 ½ inches in diameter and will be stitched on the left front. The logo includes the Los Angeles City skyline with the letters "LAPD" below the skyline. Below the letters "LAPD" is a hand shake silhouette symbolizing the Chief of Police shaking the hand of the community. Surrounding the top outer portion of the circle are the words "OFFICE OF THE CHIEF OF POLICE". Surrounding the bottom outer portion of the circle are the words "COMMUNITY RELATIONS SECTION".

The black dress shirt will be paired with charcoal colored non-utility pants. These pants have loops for a belt, two front pockets and two rear pockets. This configuration will be worn by CRS personnel during deployment at community events when Department uniform or plain clothes is not appropriate. For example; during deployment at pickup basketball games, community day events and community First Amendment demonstrations.
