SUBJECT: AREA INCLUDING NARCOTICS ENFORCEMENT DETAIL NARCOTICS ARRESTS, WARRANTS, AND OTHER MONTHLY SUMMARY, FORM 01.63.00 – RENAMED AND REVISED; AND, AREA INCLUDING NARCOTICS ENFORCEMENT DETAIL NARCOTICS ARRESTS, WARRANTS, AND OTHER MONTHLY SUMMARY, FORM 01.63.02 – DEACTIVATED

The Area Including Narcotics Enforcement Detail Narcotics Arrests, Warrants, and Other Monthly Summary, Form 01.63.00, has been renamed as Area Narcotics Enforcement Detail Monthly Summary Sheet, Form 01.63.00, and now consists of two pages. Page 2 of this form adds the original Area Including Narcotics Enforcement Detail Narcotics Arrests, Warrants, and Other Monthly Summary, Form 01.63.02, which has been deactivated by this Notice.

The use of the Area Narcotics Enforcement Detail Monthly Summary Sheet assists Gang and Narcotics Division with identifying, tracking, and disseminating crime trends specifically related to illicit narcotic activity. The data obtained using this form assists in providing current training to Department personnel engaged in narcotics-related crime suppression. This form also assists with gathering statistical data in preparation for briefings and COMPSTAT meetings. The Area Narcotics Enforcement Detail Monthly Summary Sheet has been revised as follows:

- On Page 1, at the top of the page, “Crime Analysis Detail” has been renamed as “Staff Services Section”; “at (213) 972-2546” has been deleted due to the legislative passage of California State Assembly Bill 109 (AB-109); and, “AB-109/PSP” has been added to the first column of the form;
- On Page 1, the “Total Narcotics Arrests,” the “Total Narcotics Felony Arrests,” and the “Total Narcotics Misdemeanor Arrests” headings and their corresponding boxes in the right-side column have been updated in bold font;
- On Page 2, under the heading “Narcotics Type,” the categories Chronic (gg), Freon (gallon), So. Amer. White Heroin (gg), and, Red Phosphorous have been deleted; and, Fentanyl, Honey Oil, and Other Synthetics have been added;
- On Page 2, the column headings mentioning “ND” have been renamed as “GND”; and,
- On Page 2, in the bottom box, “South American White Heroin” has been renamed as “Other Synthetics.”
