SUBJECT: LOS ANGELES COUNTY SHERIFF'S DEPARTMENT LIAISON OFFICE
NUMBERS FOR LOS ANGELES COUNTY HOSPITALS

The purpose of this Notice is to advise arresting officers that when utilizing any county health facility, they should contact the corresponding Los Angeles County Sheriff's Department (LASD) Liaison Office when the arrestee poses any health or safety risks that could impact the facility's operations. This Notice also provides an updated list of LASD contact numbers. Recently, the LASD has identified some Los Angeles County Hospitals that have encountered tactical and safety situations that involved law enforcement personnel dropping off or leaving their patients/arrestees unsecured and/or unattended. In some situations, the LASD personnel assigned to the hospital were not notified of the presence of the arrestee and a use of force occurred.

The LASD serves as the primary law enforcement agency that has jurisdiction, response, and investigative responsibility for all crimes that occur at any Los Angeles County Department of Health Services, Public Health, and Public Social Services facilities, or at any subsidiary parking areas. In order to assist law enforcement personnel, the LASD provides liaisons 24 hours/7 days a week for six Los Angeles County Hospitals and eight comprehensive health clinics. The LASD liaisons provide security details that are comprised of one sergeant, as well as deputies and contracted security officers.

Arresting officers shall continue to follow Department procedures as it relates to handling arrestees requiring hospitalization, which are set forth in Department Manual Section 4/602.10, Maintaining Custody of Arrestees who are hospitalized at a Location Other than the Jail Ward of [LAC-USCMC] and Section 4/648.10, Medical Treatment of Unbooked Arrestees.
