IN-SERVICE TRAINING COURSES AND DESCRIPTION:S

Course Title: Basic Detective Course Post Certified: Yes Reoccurrence: 4 times a year No. of Hours: 80

Description:

This one-week investigative course includes 16 modules of instruction, which familiarize students with the investigative policies and procedures of the Department. This course provides a network of resources to the personnel who are assigned to handle specific crime cases. LAPD personnel on the detective list who appear likely to be promoted will be automatically selected to attend this course.

Course Title: ICI Sexual Assault Investigations Post Certified: Yes Reoccurrence: 4 times a year No. of Hours: 80

Description:

This five-day course includes protocol for investigations involving Sexual Assault Investigations. Priority will be given to personnel who are currently assigned to investigate sexual assault crimes and major assault crimes.

Course Title: ICI Core Course Post Certified: Yes Reoccurrence: 4 time a year No. of Hours: 80

Description:

This two-week course is designed to provide investigators with the proper tools to meet the new challenges in criminal investigation. Students recover physical evidence, conduct interviews and interrogations, and participate in surveillance exercises. A case report and a search warrant are required from each participant to successfully complete the course. This course requires outside preparation (homework) for which there is no compensation. This is a voluntary course. LAPD students must sign a waiver acknowledging that they are voluntarily taking this course and they understand that no overtime for homework will be authorized.

Course Title: LAPD Gang Awareness Course

Reoccurrence: 5 times a year

Post Certified: Yes
No. of Hours: 32

Description:

The Gang Awareness course is a 24-hour POST certified course. Lessons of instruction include an overview of African-American, Asian, Hispanic, Motorcycle and Prison gangs. Modules presented also address Officer Survival, and Crime Scene Management. In addition, instruction is provided on filing preparation and expert testimony specific to gang cases. In addition to the 24-Hr Gang Awareness modules, an 8-hour Warrant Service Tactics course and practical exercise block of instruction is included in the four-day curriculum.

Course Title: ICI Gang Investigations Course Post Certified: Yes Reoccurrence: 1 time a year No. of Hours: 40

Description:

The ICI Gang Foundation Specialty course is a 40-hour course which provides investigators with information and skills to aid them in the successful investigation and prosecution of gang related crimes. The course is designed for active, hands-on participation by the students. Course work includes writing a search warrant and building a gang prosecution case.

Course Title: ICI Vehicle Theft Investigations Post Certified: Yes Reoccurrence: 2 times a year No. of Hours: 40

Description:

The instruction for this five-day course is provided primarily by personnel assigned to Commercial Crimes Division, Commercial Auto Theft Section. The modules of instruction include subjects such as Vehicle Identification; Chop Shops; Insurance Fraud; Motorcycle Theft Investigations; NICB and VIN Restorations. Several days of this course involve hands-on inspection of a variety of different vehicles and vessels. Priority will be given to personnel who are currently assigned to vehicle investigations.

Course Title: ICI Burglary Theft Investigations Post Certified: Yes Reoccurrence: 1 time a year No. of Hours: 40

Description:

The instruction for this five-day course is provided primarily by personnel assigned to Commercial Crimes Division, Burglary Special Section. The modules of instruction include subjects such as Crime Scenes related to Burglaries; Transient Crimes; Pawnshop Procedures; Computer Thefts, Organized Theft Groups and search warrant laws. Priority will be given to personnel who are currently assigned to burglary investigations or property crimes.

Course Title: LAPD Homicide Investigations Post Certified: Yes Reoccurrence: 1 time a year No. of Hours: 40

Description:

The modules of instruction for this five-day course include subjects such as Crime Scene Management related to Homicides; Serial Murders; Arson Homicides and Entomology Evidence. Priority will be given to personnel who are currently assigned to homicide investigations and/or personnel who have completed the ICI Core Course. The nominee's current assignment should be indicated on correspondence nominating a student to attend.

Course Title: LAPD Detective Supervisory Course
Reoccurrence: 1 time a year

Post Certified: Yes
No. of Hours: 24

Description:

The overall goal of the course is: "To provide students with the knowledge required to perform their role as a supervisor of investigative operations." Supervisory Crime Scene Management, Risk Management, Media Relations, Crime Reporting and Accountability, and Search Warrant Service/Planning and Tactical Operations. More specifically, the student will learn the principles of leadership, specific to their role as a Detective Supervisor. The student will learn Department policy and procedures, as well as current law as it relates to detective operations. The goal will also be served by sharing best practices, supervisory support systems and resources.

Course Title: Interview and Interrogation Techniques Post Certified: Yes Reoccurrence: 3 times a year No. of Hours: 40

Description:

This Investigator training class specifically covers interview and interrogation techniques for law enforcement investigators, featuring hands-on, experiential, prove interrogation techniques. To provide you the best law enforcement training experience possible, we require prerequisite reading and active role play participation.

Course Title: ICI Human Trafficking Post Certified: Yes Reoccurrence: 1 time a year No. of Hours: 40

Description:

This new ICI foundation specialty course provides investigators with hands-on training in the multi- faceted area of Human Trafficking and related undercover operations. This course is specifically designed for investigators responsible for handling crimes related to Human Trafficking. Students in this course are exposed to a series of various practical exercises; including sex and labor trafficking case studies, victim interviews, undercover surveillance exercises, use of website searches for out-calls, etc. This course will also provide training on Human Trafficking victimology, victim-centered approaches to investigations, laws and legal applications, potential ethical issues, evidence collection, proactive case development to include technology used to commit Human Trafficking crimes (Internet) as well as technology available to solve crimes.

Course Title: Bicycle Patrol School Post Certified: Yes Reoccurrence: 4 for the year currently scheduled No. of Hours: 40

Description:

The course provides tactics, basic patrol procedures, firearms, weaponless defense, and riding skills on bicycles. The training involves strenuous exercise and students should be in good physical condition.

Course Title: Bicycle Rapid Response Team
Reoccurrence: 3 classes prior to May Day
No. of Hours: 10

Description:

Implements bicycle rapid response tactics, bicycle formations, commands, and responding to crowd control and management situations while on bicycles.

Course Title: Bicycle Tactical Firearms Enrichment Post Certified: Yes Reoccurrence: 3 for the year currently scheduled No. of Hours: 8

Description:

Bicycle firearms and tactics training to bicycle qualified officers.

Course Title: Bicycle Patrol Preparatory School Post Certified: No Reoccurrence: 4 scheduled to prep for bike school No. of Hours: 8

Description:

The course is designed to prepare students for the 40-hour Bicycle Patrol School so that they understand both the physical requirements and skills needed to safely pass the class.

Course Title: Bicycle Patrol Update Post Certified: No Reoccurrence: 8 scheduled for the year No. of Hours: 8

Description:

The course is required to maintain Department certification for Bicycle Patrol. The course provides current / updated training on bicycle defensive tactics, skills, and policy to bicycle trained officers.

Course Title: Bicycle Advanced Skills Course Post Certified: pending Reoccurrence: 3 offerings for the year No. of Hours: 24

Description:

The course is designed to provide advanced off-road riding skills to officers assigned to any off-road detail such as the beach, parks, or local mountains. The course focuses on the safe use of electric bicycles configured for off-road use in ever changing environments.

Course Title: Unarmed Bicycle Patrol School Post Certified: No Reoccurrence: 1 No. of Hours: 32

Description:

Same basic format as the 40-hour Bicycle Patrol School, the course is for Security Services Division unarmed security guards. The course teaches riding skills, tactics and weaponless defense.

Course Title: Adjunct Instructor Update Post Certified: No Reoccurrence: 2 No. of Hours: 8

Description:

Used to enhance adjunct instructor's skills and provide current training information.

Course Title: Academy Instructor Certification Course (AICC) Post Certified: Yes Reoccurrence: Monthly No. of Hours: 40

Description:

The AICC establishes instructor training and certification requirements for academies in the program. Its purpose is to recognize demonstrated competency levels in education, and training experience for each instructor, which will improve the overall professionalism, quality, and effectiveness of law enforcement training.

The course provides programs to develop professionalism in the delivery of law enforcement instruction. The curriculum begins with a basic course and competency verification. Subsequent levels of the curriculum progressively build via a modular format, providing advancement and specialization in different areas of law enforcement training.

The curriculum is grounded in contemporary adult learning methodologies, paralanguage, critical thinking, and presentation skills. Progressive learning and proficiency in subject matter expertise, technology, design, mentoring, coaching, and leadership eventually lead to instructional mastery.

Course Title: Los Angeles Police Department Leadership Program

(LAPD Leadership Program) Post Certified: Yes Reoccurrence: Three times a year No. of Hours: 136

Description:

The curriculum consists of 136 hours of instruction and discusses 27 leadership theories. The theories are reinforced by case studies during class sessions. Each course also contains two essay examinations and a 20-page final report. Students are expected to complete 14 journal entries and all written exercises in the assigned workbook. Preparation for each class session is required and includes reading assignments, and course guide study.

Course Title: Police Science & Leadership 1: Building the Community Leader

Post Certified: No No. of Hours: 40

Note: PSL 1 is a 40-hour course, however it is always combined with Mental Health Intervention Training (MHIT). This is important to note because if an officer receives a Training Order for PSL 1 they will also be sent to MHIT. MHIT is a separate course despite the two being linked together on the training order.

Reoccurrence: PSL 1 runs every DP, C Week, Tuesday through Friday. Description:

This course will teach the Los Angeles police officer the leadership, investigative and field operational skills necessary to solve long-term problems in the community while building public trust. Utilizing the most current andragogy this training is designed to develop police officers who are empathic, relationship-focused, and prepared to work positively with and for the community they serve.

The leadership skills component will include image and impression management, fair and impartial policing, bias and how it can influence perceptions, communication skills, and community relationship development. The training will include how to identify and work to resolve the deeper concerns or underlying issues of that concern our citizens. Officers will leave the course with an understanding of why it is important for law enforcement to build and maintain public trust.

The investigative and field operations component includes constitutional policing, procedural justice, and de-escalation of force. The training will focus on utilizing communication and lesser forms of force in an effort to reduce tensions and emotions when practical. Nearly half (36 hours) of the course will be specifically dedicated to understanding persons affected by mental illness to include first-hand teaching scenarios from stakeholders that model best practices for positive police contact.

This course is community-centered and will provide professional development for officers engaged in 21st century policing. It focuses on the values, direction, and influence of the public. The course seeks to include external stakeholders from the community, and from within City Departments that work alongside the LAPD. Furthermore, the Department's overarching goal of preservation of life, and its guiding principle of reverence for human life shall be discussed at length so the young officer begins their career with a clear understanding of what is expected of them.

Time and practice is essential in this effort. Our goal is to provide this training to the officers in the field and will reoccur with every graduating academy class once it is established. The training will be systematic and will include multiple phases.

Description:

The Los Angeles Police Department (LAPD) has developed training that provides an immediate and effective tactical response to multiple organized and sophisticated critical incidents. This training expands the traditional police response to single events through the creation of dynamic squads with specific cross-training to effect "assault, support, rescue, and force protection missions". The concept was developed after observing events that took place in Mumbai, India. The LAPD has taken a leadership role and responded by developing the MACTAC concept.

The concept of MACTAC provides the means to allow officers to spontaneously and effectively control single or multiple threats as quickly as possible by using small unit infantry tactics to immediately apply pressure on assailants versus waiting and holding a perimeter. The greatest impact of MACTAC is that it allows prompt, cooperative training and response among multiple agencies. It provides the LAPD with the ability to provide high-impact squads able to respond to multiple, simultaneous critical incidents in Los Angeles and the surrounding area.

This course introduces and develops the student's basic skills in Multi-Assault, Counter Terrorism Action Capabilities (MACTAC) to a proficient level that will enable the student to immediately deploy a contact team or squad able to locate, close with and neutralize violent assaults and/or terrorist acts.

With LAPD in-service personnel having been trained in MACTAC Basic, a modified course is currently part of the Recruit Officer training curriculum during the Academy. All MACTAC Basic courses are now offered in an on-demand basis through requesting agency(s).

Course Title: MACTAC (Multi-Assault Counter Terrorism Action Capabilities) Squad Leader

Post Certified: Yes
No. of Hours: 10

Reoccurrence: 5 per year Description:

The Los Angeles Police Department (LAPD) has developed training that provides an immediate and effective tactical response to multiple organized and sophisticated critical incidents. This training expands the traditional police response to single events through the creation of dynamic squads with specific cross-training to effect "assault, support, rescue, and force protection missions". The concept was developed after observing events that took place in Mumbai, India. The LAPD has taken a leadership role and responded by developing the MACTAC concept.

The concept of MACTAC provides the means to allow officers to spontaneously and effectively control single or multiple threats as quickly as possible by using small unit infantry tactics to immediately apply pressure on assailants versus waiting and holding a perimeter. The greatest impact of MACTAC is that it allows prompt, cooperative training and response among multiple agencies. It provides the LAPD with the ability to provide high-impact squads able to respond to multiple, simultaneous critical incidents in Los Angeles and the surrounding area.

This course provides the student with the skills needed to lead a MACTAC Squad. This course is designed to develop the basic skills in leading a squad and managing Department resources and personnel. Students consist of lieutenants, sergeants and supervisory detectives.

Course Title: MACTAC (Multi-Assault Counter Terrorism Action Capabilities) Update

No. of Hours: 6

Reoccurrence: 18 per year

Description:

The Los Angeles Police Department (LAPD) has developed training that provides an immediate and effective tactical response to multiple organized and sophisticated critical incidents. This training expands the traditional police response to single events through the creation of dynamic squads with specific cross-training to effect "assault, support, rescue, and force protection missions". The concept was developed after observing events that took place in Mumbai, India. The LAPD has taken a leadership role and responded by developing the MACTAC concept.

The concept of MACTAC provides the means to allow officers to spontaneously and effectively control single or multiple threats as quickly as possible by using small unit infantry tactics to immediately apply pressure on assailants versus waiting and holding a perimeter. The greatest impact of MACTAC is that it allows prompt, cooperative training and response among multiple agencies. Course Title: Officer Safety Field Tactics (LETAC) Post Certified: Yes Reoccurrence: As requested No. of Hours: 32

Description:

The Law Enforcement Tactical Application Couse (LETAC) is a tactical course designed to reinforce and enhance an officer's basic tactical knowledge and skills. The course includes indepth discussion of Use of Force Options, Tactics, Tactical Communications, Firearms Safety and an analysis of OIS and UOF (Lethal and Less Lethal). This 32-hour course fulfills the requirements for the Perishable Skills for, Tactical Firearms, Arrest and Control and Tactical Communications.

Course Title: Officer Safety Field Tactics Instructor (TTT/OSFT)

Post Certified: Yes No. of Hours: 40

Reoccurrence: As requested No. of Hours: 4

Description:

Officer Safety Field Tactics Instructor course (TTT/OSFT) is a course designed for Training Coordinators and assistance trainers. This is a Certified Instructor course that upon completion, the student will be certified to teach the CPT (Continue Professional Training) for: Vehicle Pullovers, Foot Pursuits and Pedestrian Stops. Additionally, this course is a pre-requisite for attending the Post Certified 16 hour FOS Instructor course.

Course Title: Pedestrian Stops Post Certified: Yes

Reoccurrence: Varies No. of Hours: 2 – 4 (Varies)

Description:

This course is designed to teach student officers safety/field tactics in pedestrian stops with more advanced scenarios. Recognizing and using concepts of contact cover and tactics. The course focuses on principles of Use of Force Searching and arrests while applying those principles in specific scenarios. Course provides and is approved for 4-hour of PSP- tactical firearms.

Course Title: Vehicle Pullovers Post Certified: Yes

Reoccurrence: Varies No. of Hours: 2 – 4 (Varies)

Description:

This course is designed to teach student officers safety/field tactics in more advanced vehicle stops. This course focuses on these primary areas relative to safe vehicle pullovers, Use of Force Searching, and arrests while incorporating all aspects of training relative to arrest and control; applying those principles in specific scenarios. Course meets PSP requirements for 4 hours of tactical firearms.

Course Title: Foot Pursuits Post Certified: Yes

Reoccurrence: Varies No. of Hours: 2 – 4 (Varies)

Description:

This course is designed to teach student officers three blocks of officer safety/field tactics including pedestrian stops, vehicle stops, and foot pursuits. The course focuses on these primary areas relative to Use of Force Searching and arrests while incorporating all aspects of training relative to arrest and control; applying those principles in specific scenarios.

Course Title: Force Option Simulator Instructor Post Certified: Yes Reoccurrence: Varies as needed No. of Hours: 16

Description:

Force Option Simulator (FOS) Instructor Course is 16 hours and upon completion the student will be certified to teach the 4 hour PSP for Tactical Firearms. Additionally, the students will be certified to complete the FOS Department Qualification for the Month of June/July.

Course Title: T212 Post Certified: Yes Reoccurrence: 4 times a year No. of Hours: 4

Description:

Instruct students in the correct use, carry loading, and manipulation of the x-26 Taser.

Course Title: T312 Post Certified: No Reoccurrence: Once a month No. of Hours: 2

Description:

Course Title: T250 Narcotics/Tactical Entry Breaching Techniques

Reoccurrence: As needed

Description:

To provide students with the knowledge, skills, and techniques in breaching. Focusing on various tools that can be utilize to gain entry into a location during slow methodical searches (i.e.

surround and call-out warrants).

Course Title: T266 Ballistic Shield Train the Trainer Post Certified: Yes Reoccurrence: As requested No. of Hours: 16

Description:

To provide students with the theory & practical training necessary to effectively instruct users with knowledge, skills, & techniques in the us and limitations of the ballistic shield. Given instruction using lecture, group discussion, learning activities, demonstration, the students will learn, discuss, & demonstrate: Discuss advantages & disadvantages of the ballistic shield for law enforcement operations. Demonstrate carrying positions & movement while using the ballistic shield. Demonstrate shooting techniques using the ballistic shield. Demonstrate close quarter & retention techniques using the ballistic shield. Demonstrate the ability to incorporate the ballistic shield into existing police tactical operations. Ballistic Shield components & nomenclature. Ballistic Shield use during common law enforcement operations (i.e. warrant service, breaching, MACTAC/Active shooter, officer down rescue, building search). Demonstrate shooting proficiency utilizing the Force Option Simulator.

Course Title: Skid Course Post Certified: Yes Reoccurrence: As requested No. of Hours: 4

Description:

Emergency Vehicle Operations Course (EVOC) Skid Recovery Training

The four-hour course qualifies for the perishable skills program (PSP) mandate (1850-21157). The course provides the student with an understanding of the causes of several types of skids. The student will experience acceleration, oversteer, understeer and all wheel locked skids. The student will learn to recognize the vehicles condition and to make timely corrections to regain control and stability.

Course Title: LEDS-Law Enforcement Driving Simulator

Post Certified: Yes

Reoccurrence: As requested

No. of Hours: 4

Description:

The four-hour course qualifies for the PSP mandate (1850-20985). The simulator provides an environment for putting into practice all the elements that create a safe law enforcement driver. While not intending to replace hands on driving, the focus is placed on decision making and articulating his/her thought process. State law and Department policy provide the overall framework. Several topics are emphasized such as intersection analysis, threat prioritization, and placing the vehicle in positions of visual advantage.

Course Title: Driver Awareness Instructor Course (DAIC)

Post Certified: Yes No. of Hours: 24

Reoccurrence: As requested

Description:

Slow Speed Driving Course (Instructor Course)

The 24-hour course (1850-21815) is designed to teach and certify instructors for the four-hour POST approved PSP course (1850-29502). The students will be able to recognize the factors that affect safe driving i.e., intersection analysis, freeway driving, defensive driving, and can understand vehicle operational factors as they relate to driver ability and vehicle conditions. Emphasis will be placed on the wearing of the seatbelt and its tactical removal. Students will be able to conduct and evaluate the learning activities and exercises outlined in the Driver Awareness Slow Driving Course Handbook.

Course Title: Pursuit Intervention Technique (PIT) Post Certified: Yes Reoccurrence: As requested No. of Hours: 4

Description:

PIT Certification/Driver Training EVOC PIT

The four-hour course qualifies for the PSP skills mandate (1850-21165). The course includes all the components of the Driver Awareness Course. The course is enhanced by the inclusion of the Collision Avoidance Simulator exercise as well as Department certification in the PIT maneuver.

Course Title: Driving PSP (i.e., Slow Speed Driving) Post Certified: Yes Reoccurrence: As requested No. of Hours: 4

Description: **Driving PSP**

The four-hour course (1850-29502) qualifies for PSP. The course includes basic slow speed driving principles, driver awareness, defensive driving, and various driving course exercises intended to enhance student's efficiency and safety while operating a police vehicle at slow speeds, i.e., parking, backing and slow speed maneuvering.

Course Title: EVOC Update Post Certified: Yes Reoccurrence: As requested No. of Hours: 8

Description:

(Restorations/Remediation) Driver Training EVOC Update

The course is intended for those officers that have not returned to work for an extended period or are directed by their Commanding Officer to address a concern. The eight-hour course (1850-21115) reviews State law and Department policy. Students will safely and effectively operate an emergency vehicle utilizing the six fundamentals of vehicle control, Code-3 operational driving and slow speed driving. These exercises are meant to be a refresher and consistent with the skills they developed in the basic academy. Students will be proficient in the PIT maneuver and the deployment of a Tire Deflation Device (Stop Stick) by the completion of this course.

Course Title: Field Training Officer Update Post Certified: Yes Reoccurrence: As requested No. of Hours: 2

Description:

Field Training Officer 24-Hour Update

The two-hour block of instruction is part of the 24-hour Field Training Officer (FTO) update course. It is designed to promote vehicle awareness, leadership and ethical considerations for field training officers as it relates to the operation of a patrol vehicle. The Below 100 campaign principles are discussed and reviewed along with the concepts of intersection analysis, seatbelt usage, adrenaline, and speed. The FTO will learn to evaluate and enhance their trainee's basic driving skills by continuing to reinforce the concepts taught in the academy.

Course Title: Field Training Officer Course Post Certified: Yes Reoccurrence: As requested No. of Hours: 4

Description:

Field Training Officer 40-hour School

The four-hour block of instruction is part of the 40 hour FTO course (1850-31725). The course reviews State law, Department policy and the pursuit policy. Case law and liability considerations are presented along with the POST, Situation-Appropriate, Focused, and Educated (SAFE) Driving Program. The second half of this block of training is designed to promote driving awareness, leadership and decision making as it relates to the operation of a patrol vehicle. The Below 100 campaign principles are discussed and reviewed along with seatbelt usage, adrenaline control, speed and intersection analysis. Field Training Officers will learn to evaluate and enhance their trainee's basic driving skills by continuing to reinforce the concepts taught in the recruit academy.

A refresher course on the use of the PR-24 is given. Students utilize baton techniques on life size dummies. A refresher course of crowd control / Mobile Field Force techniques is given. This includes officer movement, use of the baton, arrest circles, and mass arrests. A PowerPoint presentation is shown to learn about the 40mm. We then go to a firing range where we train the students on the nomenclature of the weapon and then allow them to fire it. This certifies them to carry the 40mm in the field. We go outside and conduct a Mobile Field Force (MFF) exercise on the street. We take some of the students and make them part of the crowd (along with several FOTU instructors). We utilize noise makers, masks, and signs, all things normally seen in a protest. We use the remainder of the students as officers of the MFF. We do it this way to make the class as realistic as possible for everyone involved.
