SUBMISSION DEADLINES


Emergency Operations Division (EOD) is responsible for reviewing and auditing Department Standing Plans and Continuity of Operations (COOP) Plans. Standing Plans include procedures contained within the Emergency Operations Guide and the Department Manual concerning emergency control plans, single-use plans, and Area-specific response plans. Separate COOP Plans are critical to ensuring that alternate worksites are prearranged and relocation procedures are in place. The Department's ability to respond and recover from any emergency incident is incumbent upon the ability to gather and organize critical information into a standardized format.

For Calendar Year 2015, Standing Plans and COOP Plans will be due each month as assigned. These Plans shall be updated and maintained annually and COOP Plans are stored as an addendum to the Standing Plans. One complete, unredacted, hard copy along with a compact disk containing the Portable Document Format (PDF) shall be submitted to EOD by the due date indicated.


It is recommended that Bureaus initiate a project to ensure that their subordinate commands submit their completed Plans via the appropriate chain of command and approval processes. Bureaus are reminded to maintain copies of their entities Standing Plans and COOP Plans.
