**SUBJECT:** INSPECTION OF DEPARTMENT MOBILE FIELD FORCE KITS -  
MARCH 22, 23 AND 24, 2011

An inspection of the Department's Mobile Field Force (MFF) Kits will be conducted on March 22, 23 and 24, 2011, at the Edward M. Davis Training Facility, 12001 Blucher Avenue, Granada Hills, at 0700 hours in the north parking lot adjacent to Range C. Assigned personnel shall be responsible for bringing their MFF Kits and related equipment in their designated MFF vehicles. Concerned commanding officers shall direct their Emergency Preparedness Coordinators and personnel tasked with the responsibility of maintaining and deploying MFF Kits to participate as scheduled. Attached is the schedule of Areas, divisions and specialized entities to be inspected.

Emergency Operations Division (EOD) is responsible for the Departmentwide coordination and oversight of the MFF Kits. Emergency Operations Division personnel will conduct the inspection. In addition, assigned personnel from Training Division will participate by inspecting weapons and ammunition contained in the MFF Kits. New equipment will be issued as required. As mandated, the biannual inspection will assist Department entities with the maintenance and storage requirements including policy for deploying the MFF Kits during unusual occurrences.
