One complete, unredacted, hard copy of the each Plan along with a compact disk containing the Portable Document Format (PDF) of the same Plans shall be submitted to EOD by the due date indicated on the attachment. The Plans will be audited by EOD personnel and commands will be notified of any items found in the audit requiring amendment to the submitted Plans.

Please ensure that confidential mobilization rosters and other references containing employees' personal addresses/telephone numbers are redacted from the PDF version as the PDF version will be posted on the Department's Local Area Network. For those entities that have confidential personnel and/or confidential worksites, the concerned Bureau Commanding Officer shall ensure that both Plans are updated and maintained appropriately for the confidential entity and that entity will not be required to forward those plans to EOD. It is recommended that Bureaus initiate a project to ensure that their subordinate commands submit their completed Plans via the appropriate chain of command and approval processes. Bureaus are reminded to maintain an unredacted hard copy of their entities Standing Plans and COOP Plans as well.
