JUVENILE NON-DETAINED DELINQUENCY PETITIONS SUBJECT:

Effective February 1, 2014, the procedures for handling juvenile non-detained delinquency petitions submitted by Department investigative personnel will change. The District Attorney's Office will no longer accept juvenile non-detained delinquency petitions for filing consideration. These petitions must be submitted to the Department of Probation, where it will be determined which cases should be submitted to the District Attorney's Office for judicial intervention. The attached matrix reflects the new Department of Probation drop off locations based on which geographic Area the crime was committed.

There is no change in the time frame or manner in which these petitions are required to be submitted to Department of Probation, which is mandated at seven days from the date of arrest.

Investigating Officers can query the Juvenile Automated Index or contact the Department of Probation for case status updates regarding these petitions. There is no change in which juvenile detained delinquency petitions are submitted to the District Attorney's Office.
