**SUBJECT: NEW DECENTRALIZED ARREST BOOKING INFORMATION
SYSTEM CODES**

EFFECTIVE: IMMEDIATELY

Narcotics Enforcement Detail (NED) and Narcotics Division (ND) personnel shall utilize the below listed Decentralized Arrest Booking Information System (DABIS) codes when booking prisoners. Due to a recent reorganization within the Department, the outdated DABIS codes have inaccurately depicted the number of arrests made by ND in comparison to NED. With the assignment of new DABIS codes to NED, the Areas will now receive an accurate arrest count for arrests enforced by NED.

When booking arrestees, Detention Officers shall ask all booking officers which detail is to receive credit for each arrestee.

Note: All previous narcotics DABIS codes are invalid.


