"RIDE ALONG" PROCEDURES

EFFECTIVE:

Immediately

PURPOSE

This Order establishes and standardizes the procedure for approving ride alongs and activates the "Ride Along Request and Waiver" form.

INFORMATION

For many years, the Los Angeles Police Department has provided a ride along program to the community. However, there is no standardized procedure for processing those requests nor is there a standardized waiver form releasing the City of liability. This Order establishes a standardized form and procedure for processing ride along requests.

PROCEDURES

The general purpose of a ride along is to educate and open up lines of communication with the community, thus fostering an environment of mutual trust and respect. The Department will, when ever practicable, provide ride alongs to the community and members of other law enforcement agencies. Ride alongs shall be conducted by a supervisor. A ride along must be 18 years of age or older; however, a person under 18 who is a member of a Department sponsored youth program, i.e., Explorers, may participate in a ride along with the Area commanding officer's approval.

Note: All requests to ride in a police vehicle for the purpose of gathering information for published articles, and all requests from the media shall be referred to and coordinated with the Officer-in-Charge, Press Relations Section.

This Order does not affect media access of any type, or any ride along activities arranged at the direction of the Commanding Officer, Community Affairs Group, or his designee.

Employee's Responsibilities

An employee receiving a request for a ride along, shall complete the first four lines of the "Ride Along Request and Waiver" form (Temp. Form 328). The form shall then be forwarded to the concerned commanding officer.

Commanding Officer's Responsibilities

The commanding officer shall review the request and determine if it is in the best interest of the Department to approve the ride along. If approved, the request shall then be forwarded to the appropriate watch commander. If the request is denied, the commanding officer shall ensure that the person requesting the ride along is notified of the denial.

Exception:

Senior Lead Officers (SLO) may, with the patrol commanding officer's approval, conduct a ride along, (provided that the SLO's primary duty during the ride along is <u>not</u> responding to calls for service). Ride alongs assigned to SLOs shall be directly related to the SLO's duties and confined to their area of assignment.

Watch Commander's Responsibilities

Upon receipt of an approved request, the watch commander shall determine, based on deployment considerations, the date, time and duration of the ride along. The watch commander shall ensure that the person is contacted and advised of the date, time and duration of the ride along.

Prior to the ride along, the watch commander shall have the requester complete and sign the remainder of the form. After the ride along has been completed, the watch commander shall ensure the supervisor who conducts the ride along completes the lower portion of the form. The completed form shall be attached to and retained with the Watch Commander's Daily Report (Form 15.80).

Supervisor's Responsibilities

Upon completion of the ride along, the assigned supervisor or SLO shall complete the lower portion of the "Ride Along Request and Waiver" form and submit it to the watch commander.
