SUBJECT: SUPER BOWL INCIDENT MANAGEMENT TEAM PLANNING MEETING SCHEDULE

As part of the Department's preparation for Super Bowl LVI, four Incident Management Teams (IMTs) have been established. The IMTs will be responsible for the coordination and management of all Department operations related to the Super Bowl, which is scheduled to have related activities take place in and around the City from January 31, 2022 through February 15, 2022.

The attached documents contain the positions and names for all Department personnel assigned to Super Bowl IMTs as well as a schedule of upcoming planning meetings. These meetings are mandatory and shall be considered a primary duty assignment. Any personnel who are acting for a person assigned to the IMTs may attend the meetings, as appropriate. Any anticipated absences shall be reported to the employee's commanding officer and the Super Bowl Planning Committee, via Deputy Chief Al Labrada.

Our first meeting will be virtual, with the link to follow. The November meeting will take place at the selected location for the Unified Command Post. The remaining meeting locations will be based on Department guidelines and best practices concerning COVID protocols. Details about whether the meetings will be virtual or in-person, with an associated location, will be shared at least one week prior to the scheduled meeting date.
