This past Friday was October 22nd, a day to take action against state violence and honor those that have been harmed in the fight against subjugation. We continue this fight today, even as the LAPD attempts to use our protests against police violence as a reason to expand under the flimsy guise of "reformation."

In item 4B, the department lays out its plan for "Diversity, Equity, and Inclusion" (DEI) with LAPD killer cop Ryan Lee as one of the contributors. Officer Ryan Lee was the person who killed Grechario Mack in the Crenshaw Mall on April 10th, 2018, shooting even as Grechario was on the ground. Grechario was a loving father with two daughters and he suffered from mental illness, but Lee was unable to view him as a person in crisis, only as a threat, even when he was dying on the ground.
