I write to express concern about the \$65 million in expenditures made by the LAPD on technology.

Alarmingly, this is in excess of the amount spent in some cities on the entire police department. And this

is at a time when communities are calling upon municipalities to defund the police and invest in life-

affirming, not life-threatening, services. Yet, while the city of LA has been making drastic cuts to city

department budgets, the LAPD has been exempted. Contrary to claims by the Mayor, LA city has not

defunded the LAPD by \$150 million, nor has it reinvested in communities of color. For these reasons, I

call upon the Commission to take action in three important ways:

- 1) I urge you to freeze the approval of any funding requests from the LAPD until they can account for the
- \$1.7 billion of their base budget.
- 2) I also urge you not to vote on the budget this week and give at least two weeks for public comment
- on the budget, and make this budget a participatory process.
- 3) Finally, I urge you to put an immediate end to "pretextual stops" -- these are clear instances of racial profiling.
