ADMINISTRATIVE ORDER NO. 8

July 13, 2021

SUBJECT: VARIOUS DEPARTMENT MANUAL SECTIONS – REVISED, TO INCLUDE COMMUNITY SAFETY PARTNERSHIP BUREAU

PURPOSE: On August 20, 2020, Administrative Order No. 13 was published officially activating Community Safety Partnership Bureau (CSPB). This Order revises various Department Manual Sections to further integrate CSPB into Department functions. Community Safety Partnership Bureau is responsible for fostering relationships and working with community members and institutional partners to provide basic safety for residents of chronically high-crime areas. The designated Neighborhood Engagement Areas in which CSPB teams operate include Housing Authority of the City of Los Angeles public housing complexes, city parks, and other defined areas. In addition, this Order incorporates other minor revisions as they relate to recent organizational changes within the Department.
