The LAPD Centurion Football team is preparing for the 2022 season of play after a two-year hiatus. The Centurions compete in the National Public Safety Football League against teams from across the country. By participating, team members develop comradery with participants and are able to focus on personal fitness. Additionally, the team raises funds and hosts events for the Blind Children's Center of Los Angeles, an association they have held for over 40 years.

A great deal of time and effort goes into performing at a superior level. Therefore, deployment permitting, it is requested commanding officers make every effort to accommodate the team's schedule. The ability to facilitate work schedules for the members of the Centurion Football team will allow them to attend scheduled football games and practices.
