SUBJECT: NOTIFICATION TO HOSPITALS PRIOR TO ARRIVAL OF ARRESTEES
REQUIRING MEDICAL TREATMENT

In response to recent critical incidents occurring within or around hospital sites, the Office of Operations (OO) has collaborated with the Hospital Association of Southern California (HASC) to establish guidelines to safeguard Department personnel, arrestees, and hospital staff. The HASC has the responsibility of advancing the interests of hospitals located within Los Angeles, Orange, Riverside, San Bernardino, Santa Barbara and Ventura Counties. Some Los Angeles County Hospitals have reported concerns regarding the following police-related issues:

- Lack of notification or communication between law enforcement personnel with an in-custody patient and security staff assigned to a private medical facility and/or Los Angeles County Sheriff Department's (LASD) Liaison Office, and emergency room personnel;
- Officer-Involved Shootings occurring within or around hospital sites;
- Tactical concerns when a patient's medical diagnosis requires x-rays from machines such as Magnetic Resonance Imaging (MRI), Computed Tomography (CT), and/or Computed Axial Tomography (CAT);
- The application of handcuffs or non-ferrous restraints and their dangerous reaction with imaging equipment; and,
- Discrepancies between state and federal policies on the application of restraints while maintaining patient healthcare.

To help prevent any of the above-mentioned scenarios from occurring, all arresting and/or transporting officers having custody of an injured or sick suspect/arrestee requiring medical treatment or hospitalization, should notify the respective medical facility security watch commander's office or the LASD Liaison Office prior to arriving at a private medical or county health facility.

Note: Officers can request Communications Division to contact the designated receiving private hospital security watch commander's office and/or the LASD Crisis Response Team (CRT) office for a suspect/arrestee and/or victim requiring emergency medical treatment. When emergency medical attention is necessary, officers shall be guided by Department Manual Section 4/210.15.


When making notification, officers should inform the emergency room personnel, security staff or LASD Liaison Office personnel of any health hazards, behavioral factors and/or contagious diseases that could impact the hospital staff, patients, visitors and others within the hospital environment. This information will assist the respective medical facility in deploying the appropriate levels of security and medical staffing to maintain control methods that assist in de-escalating the patient's behavior, or to control the actions of a violent patient who requires medical intervention.

A comprehensive list of both private and county-run medical facilities, as well as the respective security contacts at each location, has been attached to this Notice for reference.

Note: The LASD is the primary law enforcement agency that has jurisdiction, response, and investigative responsibility for all patients that are admitted into any Los Angeles County Medical Facility.

To assist law enforcement personnel, the LASD Liaison Office provides a CRT or a Behavioral Response Team to manage patient healthcare. Security staff and LASD Liaison Office personnel can also assist officers with information regarding facility layout, radio and cell phone reception areas, and any locations of concern within frequented areas used by law enforcement personnel to minimize the possibility of radio transmission issues that can hinder an officers' ability to broadcast pertinent information/requests.
