In accordance with Government Code Section 54953, subsections (e)(1) and (e)(3), and in light of the State of Emergency originally proclaimed by the Governor on March 4, 2020 relating to COVID-19 and ongoing concerns that meeting in person would present imminent risks to the health or safety of attendees and/or that the State of Emergency continues to directly impact the ability of members to meet safely in person, meetings of the Board of Police Commissioners will be conducted entirely via videoconference and teleconference, and telephonically. The meeting will not be conducted at the Police Headquarters Facility, 100 W. 1st Street, Los Angeles, CA 90012. Members of the public are invited to address the Board of Police Commissioners on agenda items and on any matter within the subject matter jurisdiction of the Board during the public comment period. All public comment will be heard at the beginning of the meeting. Time cannot be ceded to another speaker, and an individual may speak only once during the public comment period. Every effort will be made to accommodate as many speakers as possible, however, some members of the public may not be heard if the number of speakers exceeds the amount of time allotted for public comment. The chair may manage the meeting and the public comment time allotted in consultation with the City Attorney. Members of the public will have one (1) minute per agenda item, up to two (2) minutes total. At the request of the speaker, the speaker will be afforded an additional one (1) minute for general public comment, for a maximum of three (3) minutes total. The Board shall take a total of 45 minutes of public comment.

Determination in accordance with AB 361 whether meeting in person presents imminent risks to the health or safety of attendees and continues to directly impact the ability of the Board members to meet safely in person because of the continuing state of emergency related to the Covid-19 pandemic. Possible Board action. Government Code section 54953(e)(1) and (e)(3).

Recommendation(s) for Board action:

Find the following: While on February 22, 2022, the Governor issued a Proclamation rescinding various COVID-related provisions, the COVID-19 State of Emergency declared by the Governor on March 4, 2020 is still active and remains in effect. The continued State of Emergency and the persistence of the highly contagious COVID-19 variants in Los Angeles County, as reported by the CDC COVID-19 tracker, create circumstances that directly impact the ability of Board members to meet safely in person. Additionally, on March 1, 2022 the City Council found that the State of Emergency directly impacts the ability of all City Brown Act bodies to meet safely in person. In accordance with AB 361, this Brown Act body has reconsidered the circumstances of the State of Emergency and that the State of Emergency continues to present imminent risks to the health and safety of attendees and continues to directly impact the ability of Board members to meet safely in person.

4. CONSENT AGENDA ITEMS

The Consent Agenda items are considered to be routine and non-controversial upon which documentation provided to the Board is adequate to give sufficient information for approval without inquiry or discussion. It is designated to minimize the time required for the handling of routine matters in order to permit additional time to be spent on more significant matters.
