They fly *low* enough to violate our fourth amendment rights to privacy. They fly *often* enough to disturb the peace. Please reconsider their use, and look low-tech to more non-lethally armed foot patrols.

Choppers are the loudest, worst presence in my community (Hollenbeck Division, El Sereno/Rose Hills). Second is illegal fireworks, something vice units should get into (join with County Fire Arson Investigators), go undercover and root out (even if it takes us to New Mexico/Nevada lines). To folks with PTSD and our pets, use of illegal fireworks is clearly a violent crime, injuries mounting up with it every year...

On Lethal Force:

I recently spent some time with an LAPD officer, who went over a variety of potentially lethal situations he and his fellows face while on the job, trying to protect and serve. He was surprisingly convincing, had me on the edge of my seat, and I was close to renouncing some of my religious views—the main one with relevance being the Sixth Commandment of the Jewish Torah:

Thou shalt not kill.

The officer was convincing with the set of conditions in front of him, as a lethally trained officer, *but*... After a few days to meditate, I recalled the big picture. Stolen Native American land... Guns and more guns rationalized by bibles, then the forced industrialization and development of this once thriving wilderness turn New Europe.

In the insanity civilization has created, the normalization of fast cars, planes, and even the loud war machine helicopters above us claiming law enforcement: one could argue that indeed some people need killing. An insane notion made almost palatable on the concrete and asphalt of this city: law officers speeding around in fancy cars burning earth, flying around over our homes burning more earth—

Showing up mid-conflict... someone draws a knife, or a gun, or a machete... and now? The police officer called in with few facts and limited knowledge of a crime scene shows up to make a life or death decision with his or her lethal firearm. They trained to kill, trained to shoot for the largest mass on the human body—the torso, the chest, the heart... to kill.

And given all of that, all that touring around in fire-burning vehicles across this once natural area turned polluted metropolis: they are out of touch. Their boots are not on the ground. They don't know the suspect nor the suspect's family. They often know only a little about the community they enforce, and what they do know they know driving at high speeds or worse yet, flying loud metal choppers from above us.

Lethal force in policing is always wrong, I still assert. Even after an LAPD officer's impassioned plea to me and set of scenario explanations... Why? Because the concept of "America," land theft and the forced industrialization of this land has created the insane situations they experience that only *seem* to justify the taking of human life on the job.

I reject lethal force. I reject lethal force training. But well before that, I reject "Los Angeles," the "United States of America" and any other concepts deriving from a racist, criminal theft of land some like to call a romantic conquest so they can keep benefitting from sin. Putting down our guns may not be the first step toward proper amends, but it is one.

It's time to question the founding of this New Europe on stolen Native American land, where gun use is too often justified in the loud, polluted insanity industrialization has created here.

An attacker's or wrongdoer's *heart does not have to stop for them to no longer be a threat.* Killing a wrongdoer is overkill to true defense. We need a scientific review of real defense; we need to look outside the box for better, more inventive non-lethal approaches.

The United Kingdom, whose Robert Peelers and Bobbies founded modern policing, chooses to patrol its communities with officers only 10 percent lethally armed. (<u>https://www.nbcnews.com/news/world/why-london-won-t-arm-all-police-despite-severe-terror-n737551</u>)

90 percent patrolling without guns! True policing, Robert Peel put forth, depended on the *consent of the people*. By the sound of callers calling in, you have the support of some of us, but it is obvious that a majority consent is not there to routinely patrol with lethal force.

Helicopters Part Two:

Neither do I see any proof of the people's consent to patrol our communities with *helicopters*. A NASA study was done over fifty years ago in 1970, and a poll was done in two divisions. (<u>https://travelingpoet.net/2019/09/17/old-science-cant-justify-lapd-choppers/</u>) Noise complaints were recorded, but some citizens supported the choppers—

Which seemed enough for you to publish that:



Commissioners,

On this week's agenda, there are three demonstrations of how the City of Los Angeles, LAPD, and technology corporations use Los Angeles neighborhoods as testing and development grounds for policing technology and military surveillance tactics. As Angelenos continue to demand housing, services, youth programs, and investment in schools, the LAPD and LAPF (Los Angeles Police Foundation) continue to pump money into policing, and profit from the results.

LAPD wants nearly \$14M to upgrade its Records Management System (RMS). The five-year contract would go to Motorola Solutions Inc., which offers "faster and easier" records management for every piece of information obtained by or sent to LAPD, as well as every piece of information transmitted, stored, or shared between LAPD and its many partners. Former LAPD Chief and current paid Rick Caruso consultant Bill Bratton was placed on the board of Motorola Solutions in 2011.

It's no surprise that LAPD would give a contract to Motorola, a corporation that helps channel money to LAPD, both through donations to LAPF - where Motorola salesperson Hugh O-Donnell was a long-time board member, and where Joseph Warner, Senior Account Executive at Motorola sits on the board now - and by serving as a willing partner in LAPD's experimental and carceral surveillance tactics in Black, brown, and poor neighborhoods. With its technology, Motorola will continue its tracking and criminalization of people in LA, this time based on a person's movements or very appearance on video, with software that claims to "transform video surveillance from reactive monitoring to automated proactive alerts" when a person, object or vehicle "of interest" is detected by cameras. There is no mention of how this will work, though the software does incorporate technology from Motorola acquisitions Avigilon and WatchGuard, both of which specialize in video analytics and facial recognition.

LAPD further wants to increase funding to Axon, another long-time corporate partner with deep connections to the department, including that former COP Charlie Beck sits on Axon's so-called AI Ethics Board. With a \$6.9M contract, the city of LA wants to pay Axon for an in-fleet recording platform to add two cameras to 1500 cop cars. Mentioned nowhere by LAPD is that each camera will also have the ability to scan license plates; meaning 3000 Automatic License Plate Readers (ALPRs) will be added to LA streets, constantly gathering information for potential use as "evidence." This is a shameful use of city funding as we demand more services, not more spying and surveillance.

Additionally, the Police Foundation is funding software for LAPD's drones for Traffic Group to create geospatial maps of areas over which drones have flown. We rejected LAPD use of drones in 2014 and 2017 when they were proposed as weapons of surveillance, and we reject them today! LAPD does not need drones. Part of LAPD's militarized occupation and assault includes surveillance

from the air, which is accomplished in part by LAPD drones. We continue to reject the use of drones for LAPD.

Finally, remove the limitations on public comment! Members of the communities most affected by policing are by far the most knowledgeable about the real-world effects of the matters before the board, and about LAPD in their neighborhoods, and you need to hear what they have to say.
