I hope this email finds you well. I wanted to give the general public a visual as to the Covid numbers that Chief Moore has reported on during the Police Commission meetings year to date. This graph shows what Chief Moore has reported but there still is missing information that has not been disclosed. I have a strong reason to believe the missing data will only increase the total number and percentage of your vaccinated personnel.

Chief Moore did not disclose / breakdown the Covid numbers for the following dates.

All of this missing data is a part of Agenda item #1 that Chief Moore reports to the Police Commission, yet none of the Police Commissioners have ever asked for this missing data after Chief Moore gave his report.

January values are represented on the graph with one report on Covid even though there were two meetings February's values are also represented on the graph with one report on Covid even though there were two meetings. March's values are represented on the graph with three reports on Covid even though there were four meetings Aprils values are represented on the graph with two reports even though there were three meetings. May's values are represented on the graph with two reports even though there were four meetings.

As you can see, your Covid mandate in the interest of "Public Safety" is not working. Your own data along with the world-wide data shows the same result.

Thank you for taking the time to read through this, I would appreciate you including the graph provided in this email. This data provided on the graph is from Chief Moores reports to the Police Commission since January of this year. The data on the graph is accurate per Chief Moore's reports as of 8/23/2022.

Including data from previous variants that we are no longer dealing with or including data from when the City of Los Angeles first implemented the vaccine mandate is not being transparent with the public to show the current trends. Not properly providing a breakdown on your Dept's Covid numbers doesn't help with being transparent either.
