DISTRICT ATTORNEY INVESTIGATORS

District Attorney Investigators conduct unique, sensitive, and complex investigations in the County of Los Angeles. The purpose of this Training Bulletin is to familiarize officers with the authority and functions of the District Attorney Investigators encountered in the field.

The District Attorney is empowered to employ investigators by the County Government Act of 1897, the Los Angeles County Charter, and the Government Code. District Attorney Investigators carry firearms and have full peace officer authority, equivalent to county deputy sheriffs and city police officers under California Penal Code Section 830.1.

Investigators assigned to the District Attorney Bureau of Investigation primarily provide investigative and trial support to prosecutors and may contact the officers listed as the arresting/reporting officers, victims, or witnesses. They also have jurisdictional responsibilities to investigate local government corruption, complex fraud, organized crime syndicates, computer-related crimes, major county code violations that impact "quality of life" issues, and actively participate in various inter-agency law enforcement task forces.

District Attorney Investigators conduct surveillance operations and serve arrest or search warrants in the County and City of Los Angeles. District Attorney Investigators may also assist law enforcement agencies with complicated and multi-jurisdictional cases. They can provide special assistance with vehicular and electronic surveillances as well as serve as a force multiplier for local law enforcement, providing investigative and operational support for the most critical probation violation cases, parole compliance checks, and saturation enforcement of areas that experience high rates of community violence.

District Attorney Investigators may dress in suits, casual clothes, or tactical gear depending on their assignment. When serving arrest or search warrants, their policy dictates that investigators dress in a black, full tactical uniform. The vehicles assigned to the District Attorney Investigator's office range from fully-equipped emergency vehicles to undercover and "E" plate vehicles.

District Attorney Investigators may be reached through the District Attorney Command Center which provides a representative of the Los Angeles District Attorney to local law enforcement agencies on a 24-hour basis. Necessary notifications (e.g., officer involved shootings, crimes against peace officers, erroneous releases, in-custody and industrial deaths) can be made to the Command Center. The Command Center also assists with obtaining after-hours search warrants, telephonic warrants, and assistance with legal questions on Probable Cause Declarations.

#### **BUREAU OF INVESTIGATION**

The District Attorney's Bureau of Investigation is charged with the responsibility of conducting investigations under the immediate direction of the Chief of the Bureau of Investigation. The District Attorney's Bureau of Investigation administers the Witness Relocation Program under the direction of the Chief Deputy District Attorney for Los Angeles County. A duty captain in the District Attorney Bureau of Investigation is designated as coordinator/liaison for all law enforcement agencies.

Relocations fall into two categories: Non-Emergent (by appointment) and Emergency Relocation (24/7). For relocation requests, the duty captain may be contacted through the District Attorney Command Center. Relocation authorization can be made telephonically. After receiving telephonic approval, the investigating officer must contact the authorizing captain within five business days and complete a California Witness Relocation Assistance Program application (CalWRAP-1).
