Good morning, Police Commissioners, I wish you all a very Happy New Year. Before I begin, I would like to start off with a quote from Lois P. Frankel, **"You may have what it takes to be successful, but if you lose yourself in someone else's priorities, you will be judged not by your potential but rather by your history."** 

You have all listened to one year's worth of data pertaining to the city of Los Angeles Covid-19 mandate. You have all chosen to ignore the public's concerns and allow questions go unanswered. It's a new year now and a new beginning. If we do not learn from our past, we are destined to repeat it. This year let's start being open and honest to the public, take a stand and do the right thing even if it goes against the grain.

Influenza cases in California have risen to levels that haven't been seen in years. The CDC stated that seasonal Influenza activity is high and continuing to increase across the country.

The L.A. County Department of Public Health has seen a significant increase in the percentage of specimens that have tested positive for Influenza.

On **12/4/2022** CBSLA reported that experts say the combination of Covid-19, Influenza and RSV are putting an enormous strain on hospitals. Per the CDC Influenza levels are off the chart in California with Los Angeles and Southern California leading the State. According to the experts, 25% of the people that tested for Influenza in Los Angeles have tested positive for Influenza.

Even with viruses on the rise, one expert says that reinstating the mask mandate should be a last resort. Board of Police Commissioners,

As a longtime resident of Los Angeles and an observer of the LAPD over many years, I strongly advise that the Board of Police Commissioners and Mayor Bass not reappoint Michel Moore to another term as Chief of Police. The reasons to not reappoint Moore as Chief are listed below in no particular order.

1. Moore often speaks of building trust with the community but it is clear that by his own words and actions he has caused the loss of public trust across the political spectrum and the rank and file of the LAPD. Moore has made too many misstatements mischaracterizations of incidents and situations, and bad personal decisions that have negatively affected Department morale and diminished public trust. A review of public comment at BOPC meetings every Tuesday would bear this out. Additionally, Moore does not have the trust and confidence of the LAPD rank and file as reported in a Survey of LAPD personnel in the Los Angeles Police Protective League magazine 'The Thin Blue Line" where the cover story of the November 2020 issue is about the Employee survey. Close to 90% of the rank and file do not have confidence in Moore and the entire Command Staff. That is a problem and things will not change for the better until that problem is dealt with.

2. Moore is not perceived to be a strong advocate for the rank and file officers. I know this because I talk to many officers and my conversations lead me to believe that they suffer from low morale and Moore is largely responsible for that. The infamous incident of Moore taking a knee for blm while officers were on the front lines being pelted with rocks and bottles and being attacked and property being destroyed is a major sore point for officers and rightfully so. Moore taking a knee is seared into the memory of officers and it is widely considered to be a disgrace that will go down in LAPD history as a moment of embarrassment and shame. As a citizen I concur with the LAPD rank and file and I personally believe that any LAPD officer that took a knee is a disgrace and have dishonored their badge and should turn in their dishonored badge.

3. It is no secret that the LAPD has had a recent spate of officers arrested for DUI and while it is not the first time a spate like this has occurred, it is widely known that there is a video of Moore in Las Vegas appearing to be intoxicated and unsteady in a bar area. Is that the kind of example he should be setting for LAPD personnel? The Chief is a highly public figure and is always the Chief whether on or "off duty". That kind of behavior is unacceptable and shows poor judgement. That kind of behavior does not increase public trust but diminishes it. And according to officers I have spoken to this is not an isolated incident and has been observed here at home in LA at Dodger Stadium. What should happen if a major incident occurred at Dodger Stadium or any other venue where he is impaired? Would he be able to assume his role as incident commander? He is the Chief at all times but the answer is obvious. Los Angeles and the LAPD would suffer a major embarrassment.

4. Community Policing has suffered under the term of Chief Moore. Community meetings are just now being mentioned by Moore in the Chiefs report and that is only after the fact. Taking the pandemic into consideration, Moore has not led the community policing movement as evidenced by the disconnect between the Department and the people

on a large scale but with notable exceptions. Take a look at the LAPD website. It doesnt bring the police and people closer together in partnership. It doesnt list important events and neighborhood watch meetings. Consequently, Community Policing is not inclusive, lacks diversity and is inequitable and Moore should held to answer for that.

Clearly Moore is too much of a risk and liability for the city of Los Angeles. Should you reappoint Moore and a disastrous incident occurs due to his impairment and poor decision making you will be held to answer the public! Is that a risk worth taking. It is clearly obvious that for these reasons listed and other reasons it is time for Los Angeles and the LAPD to go in a different direction by appointing a new Chief of Police for the benefit of the public and the LAPD itself.

#### Commissioners,

This week the Board will vote on the revised rules for public attendance and participation for in-person meetings of the Board of Police Commissioners. The proposed rules would be a marked change from what was previously in place, and would dramatically reduce the ability of community members to give public comment in person. These new restrictions are a blatant attempt by the Board to further silence and discourage participation from community members and organizers who attend the meetings, and are part of a larger trend in the city of Los Angeles to restrict public comment and participation at Commission and Council meetings, and to quell dissent.

What's being proposed includes the following:

Limiting total time for public comment to 45 minutes per meeting, with a maximum of 3 minutes per speaker for the entire agenda, which can contain 10-15 different items, sometimes more.

Presumably, public comment would still go at the beginning of the meeting, prior to any discussion or any presentation on agenda items. This in particular is thoughtless and dismissive of the comments and questions of community members, and intentionally seeks to limit public comment on the specific matters at hand.

Rules for the content of speech include: "speakers shall refrain from making repetitious remarks..." The fact that the Board seeks to limit public comment to only 45 minutes and then also places such restrictions on speech speaks to its utter lack of respect and tolerance to actually hear from members of the public on anything they want to speak on, regardless of whether or not a person is repeating a point.

There are already many barriers to attending Police Commission meetings, particularly in the midst of an ongoing pandemic. A person must be able to get the morning or day free from having to work or provide care or support to family members, and additionally must have some form of transport. Once at the meeting location, a person must be able to go through security and be willing to sit in a small and crowded room with cops in close proximity. For folks who have had loved ones shot or killed by police, all of this is a thousand times more excruciating. But the members of Police Commission can't find in themselves the capacity to listen to every person who hands in a comment card. This is inhumane and deplorable. How highly you think of yourselves.

LAPD has disproportionately killed Black folks, houseless people, and those suffering from mental challenges and/or substance abuse. Moore does not appear to enforce de-escalation as a philosophy or plan for LAPD. He consistently approves the harm as necessary and "in-policy." If and when a shooting is designated out-of-policy by him or the Commission, officers are almost never disciplined or held accountable in any way.

As a result of excessive LAPD violence against peaceful protestors in 2020 following the police/white-supremacist murders of George Floyd, Breonna Taylor, and Ahmaud Arbery, several lawsuits, including one of the most significant class-actions in history, were filed. The investigative report developed around the harms names Moore's failure to properly plan and worse his "direct approval" of many of the abusive tactics to be at fault. Some of these suits have resulted in the City having to pay out enormous sums because of Moore's failures. In spite of these facts, Moore continued to allow this behavior in 2022, as those protesting the overturning of abortion rights were brutalized, arrested, and intimidated by LAPD.

In 2021, Moore oversaw a planned detonation, which was communicated to the media as an anti-fireworks stunt. The explosion was not contained and, horrendously, the lives of Auzie Houchins and Ramon Reyes were cut short; the long-time residents and community pillars died in the explosion's aftermath. The explosion also resulted in the destruction of an entire city block in South LA. Houses, apartment buildings, businesses, vehicles, and property were destroyed, as the explosion dislodged residents from their homes. Many former residents of this tightly-knitted community are still suffering and have not been adequately compensated. Beyond the human toll, the explosion cost the City many millions of dollars.

As a reminder, the list of harms committed by Chief Moore is long. During his tenure he: used a white-supremacist media outlet (Breitbart) to recruit LAPD applicants, enabled anti-Black racism by allowing Black people to be stopped by LAPD at 5 times their population share and searched 3 times the rate of other races, fostered a culture of corruption where officers in South Central were found to have illegally and unjustly entered the names of Black and Brown residents into gang databases, presented internal investigations that repeatedly avoid accountability, including finding that not a single one of 4863 racial-bias complaints filed by the public was valid, stated that protestors in 2020 were just as responsible for the death of George Floyd as were the officers who killed him, created a culture where officers were enabled to circulate a "Valentine Card" with a despicable reference to Mr. Floyd and the words "you take me breath away" on LAPD's internal online communication system, refused to disclose or publicly hold accountable the LAPD

officers who participated in the attack of the U.S. Capitol on January 6, 2021, publicly compared Black Lives Matter to the right-wing extremist group the Proud Boys stating that both "represent ideology that's counter to democracy," lied on the record to the public about the number of traffic stops made in South Central in 2021, stating the number was 74, when the actual recorded number was 639 - a number revealed by the media, enabled the targeting, intimidation, arrest, and "swatting" of movement activists and organizers, "double-dipped" by unethically taking both a \$1.3 million lump sum retirement and a nearly \$400,000 annual salary, allowed for the flying of racist flags on LAPD buildings, turned a blind-eye to officers who drive under the influence and abuse their spouses, permitted cops to spread COVID in the department and in neighborhoods by refusing vaccinations and not masking up, and allowed for crime rings to form by officers who do everything from sell LAPD firearms to commit sexual assault.

Our list of grievances against Chief Moore is much longer, and includes his personal three shootings of Angelenos when he was a beat cop. He has established a record of mismanagement, deceit, corruption and brutality. While these harms have impacted the entire City, they have had a particularly brutal effect on Black and poor communities. We need change. Chief Moore must not be reappointed.
