Good morning, Police Commissioners, I hope you all are very well. Before I begin, I would like to start off with a quote from Jacob Bronowski, "No science is immune to the infection of politics and the corruption of power."

On January 10, 2023, Chief Moore provided a Covid report for December 20th & 27th of 2022. There was a total of **135 new positive Covid-19 infections** from these two reporting periods. From these 135 new infections, **107 were vaccinated** employees and **28 of the 135 were unvaccinated employees**. From January 11, 2022, to December 27, 2022, the vaccinated made up 78% of the reported new positive Covid-19 infections within the LAPD. These figures are based upon Chief Moore's numbers that he provided during Police Commission meetings on Covid infections. There are seven times that a Covid-19 report either was not given or was incomplete. Those dates are, 1/11/22, 2/08/22, 3/15/22, 4/12/22, 5/17/22, 5/24/22, 7/26/22.

On January 10,2023, Chief Moore further provided a breakdown for January 3rd & 10th 2023. For these two reporting periods there were a total of **117** new positive Covid-19 infections within the LAPD, **94** of the **117** are from vaccinated employees. These two reporting periods the vaccinated employees are making up 80% of the total new positive Covid-19 infections within the LAPD.

The City of Los Angeles under Mayor Garcetti authored the Covid-19 mandate, that requires ALL city employees to become vaccinated against the Covid-19 variants. This was done in efforts to stop the spread of Covid-19 and to "protect the City's workforce and the public that it serves". A complete years' worth of your own data show that **78% of the Covid-19 infections are from vaccinated employees**. Can someone please

LAPD has disproportionately killed Black folks, houseless people, and those suffering from mental challenges and/or substance abuse. Moore does not appear to enforce de-escalation as a philosophy or plan for LAPD. He consistently approves the harm as necessary and "in-policy." If and when a shooting is designated out-of-policy by him or the Commission, officers are almost never disciplined or held accountable in any way.

As a result of excessive LAPD violence against peaceful protestors in 2020 following the police/white-supremacist murders of George Floyd, Breonna Taylor, and Ahmaud Arbery, several lawsuits, including one of the most significant class-actions in history, were filed. The investigative report developed around the harms names Moore's failure to properly plan and worse his "direct approval" of many of the abusive tactics to be at fault. Some of these suits have resulted in the City having to pay out enormous sums because of Moore's failures. In spite of these facts, Moore continued to allow this behavior in 2022, as those protesting the overturning of abortion rights were brutalized, arrested, and intimidated by LAPD.

In 2021, Moore oversaw a planned detonation, which was communicated to the media as an anti-fireworks stunt. The explosion was not contained and, horrendously, the lives of Auzie Houchins and Ramon Reyes were cut short; the long-time residents and community pillars died in the explosion's aftermath. The explosion also resulted in the destruction of an entire city block in South LA. Houses, apartment buildings, businesses, vehicles, and property were destroyed, as the explosion dislodged residents from their homes. Many former residents of this tightly-knitted community are still suffering and have not been adequately compensated. Beyond the human toll, the explosion cost the City many millions of dollars.

As a reminder, the list of harms committed by Chief Moore is long. During his tenure he: used a white-supremacist media outlet (Breitbart) to recruit LAPD applicants, enabled anti-Black racism by allowing Black people to be stopped by LAPD at 5 times their population share and searched 3 times the rate of other races, fostered a culture of corruption where officers in South Central were found to have illegally and unjustly entered the names of Black and Brown residents into gang databases, presented internal

investigations that repeatedly avoid accountability, including finding that not a single one of 4863 racial-bias complaints filed by the public was valid, stated that protestors in 2020 were just as responsible for the death of George Floyd as were the officers who killed him, created a culture where officers were enabled to circulate a "Valentine Card" with a despicable reference to Mr. Floyd and the words "you take me breath away" on LAPD's internal online communication system, refused to disclose or publicly hold accountable the LAPD officers who participated in the attack of the U.S. Capitol on January 6, 2021, publicly compared Black Lives Matter to the right-wing extremist group the Proud Boys stating that both "represent ideology that's counter to democracy," lied on the record to the public about the number of traffic stops made in South Central in 2021, stating the number was 74, when the actual recorded number was 639 - a number revealed by the media, enabled the targeting, intimidation, arrest, and "swatting" of movement activists and organizers, "double-dipped" by unethically taking both a \$1.3 million lump sum retirement and a nearly \$400,000 annual salary, allowed for the flying of racist flags on LAPD buildings, turned a blind-eye to officers who drive under the influence and abuse their spouses, permitted cops to spread COVID in the department and in neighborhoods by refusing vaccinations and not masking up, and allowed for crime rings to form by officers who do everything from sell LAPD firearms to commit sexual assault.

You allow LAPD to use in-car and body-worn cameras under the guide of "holding police accountable" but continue to not hold police accountable and to rubber stamp their policies when cameras do show police misconduct. Furthermore, LAPD just edits the camera footage they have to promote themselves and to avoid being held accountable, rather than releasing unedited footage of their brutality.

In addition, LAPD's use of this surveillance also benefits their partners, Axon Enterprises, who profit off of carceral technologies and the unethical collection of "data" on marginalized communities.

The research clearly states that BWV and In-car video do not decrease police murders or reduce racist stops or prevent deaths by police. BWV and in-car video do not lead to police prosecutions or a reduction in police force. LAPD needs to be defunded from their surveillance of the community!

Already in 2023 LAPD have killed three people who were in crisis Keenan Anderson, Oscar Leon Sanchez, and Takar Smith. This continued police violence has devastating consequences for communities and families, with Black communities being most deeply impacted.
- Chief Moore oversaw LAPD while it targeted protestors during the 2020 uprising following the murder of George Floyd, Breonna Taylor, and countless other victims of police violence. Protestors were attacked, injured, jailed, and harassed, resulting in thousands of complaints filed and hundreds of reports of injuries

- sustained by LAPD. Moore then used the protests as an opportunity to further increase funding for the department, including the surveillance of protestors and dissent.
- 3. In the course of his tenure, LAPD performed a publicity stunt to detonate fireworks taken from a home in South Los Angeles, while still within the community, and without effective evacuation. The explosion resulted in injuries to 17 people including Auzie Houchins and Ramon Reyes, who ultimately died from the shock and stress.
- 4. Chief Moore covered up the the actions of officers who killed one of their own, Houston Tipping, during a training exercise after Tipping filed a report on the rape of a woman by four LAPD officers, one of whom took part in the training where Tipping was killed
- 5. Chief Moore oversaw LAPD during the December 2020 assault on protestors taking part in a demonstration with BLM-LA outside the Mayor's mansion, in which members of the crowd were beaten with batons.
- 6. Chief Moore created a culture where cops were enabled to circulate a "Valentine Card" with a despicable reference to George Floyd and the words "you take my breath away." Chief Moore promised he would hold accountable the perpetrator of this gross act, but then did not.
- 7. In his course of his tenure, LAPD continued racialized stops of Black pedestrians and drivers, which Moore defends by presenting LAPD's crime reports through the lens of race: a decades-old tactic to falsely imply race and criminality are linked while justifying the deeply racist policing of LAPD.
- 8. Chief Moore proclaimed not once but twice that those who protested the murder of George Floyd were just as responsible for his death as the police who killed him.
- 9. Chief Moore denied LAPD was responsible for the deaths of Janisha Harris and Jamarea Keyes in August 2022 even though they were the ones who chased a driver through a red light and caused a fatal crash.
- 10. Chief Moore lied on the record to the public about the number of traffic stops made in South Central in 2021, stating the number was 74, when the actual recorded number was 639, a number revealed by the media.
- 11. Chief Moore publicly compares Black Lives Matter to the right-wing extremist group the Proud Boys, stating that both "represent ideology that's counter to democracy."
- 12. Chief Moore Continued a culture and system in which Metro police officers felt empowered and entitled to enter people they stopped into California's gang database without justification.
- 13. Chief Moore has robbed the budget of the city of LA in 2018 by unethically taking both a \$1.3 million lump sum retirement and a nearly \$400,000 annual salary.
- 14. Chief Moore failed to act on behalf of an LAPD captain who was being sexually harassed at work.
- 15. Chief Moore has continuously Ignored the demands of approximately ⅔ of Angelenos who consistently and loudly demand that LAPD is defunded

We need a chief that will prioritize the diversion of police calls to mental health responders and community ambassadors. Moore *said* he would be open to that but has done nothing to actually do that.

General Public Comment: Allowing Public Comment

Allow community members to speak after every single agenda item, as opposed to continuing the patently ludicrous practice of forcing the public to speak before any of these items have been discussed. Inform the public who is up next to speak. Resume in-person meetings. In general, make every effort to remove procedural barriers and impediments to civic expression, and discontinue your visible displays of irritation with and hostility towards the public you purport to

serve. Members of the communities most affected by policing are by far the most knowledgeable about the real-world effects of the matters before this board, and about LAPD in their neighborhoods, and you should be doing everything you can to make it easy for them to give public comment. Week after week, your actions belie your hollow claim to be the "citizen's voice in police affairs."
