Good morning, Police Commissioners, I hope everyone is doing well, I would like to start off by sharing the difference between a Leader and a Follower. *Leaders* are not paralyzed by fear, they thrive on it. They tackle it head on and show it who's boss. *Followers* want direction, they need step by step instruction. They require constant assurance and approval, often as a means to cover themselves should something go wrong.

What category would you consider yourself being in, and will the public's perception align with yours?

Chief Moore, congratulations on being appointed for another five years. I'm certain these past few weeks not knowing your fate was rather stressful and it probably feels like a ton of bricks has been lifted off your chest knowing that you will receive your Police Chief pension. I have empathy for the employees of the LAPD that haven't known their fate for over two years now.

As of January 2023, the LAPD has had a **total of 221 positive Covid-19 infections**. **185 of the 221** are from **vaccinated** employees within the LAPD. **36 of the 221** are from **unvaccinated** employees within the LAPD. Can someone, anyone at this point confirm or deny the City of Los Angeles is only testing the unvaccinated employees for Covid-19? I have made several inquiries and still have not received an answer. Many sources are saying the City of Los Angeles is only testing the unvaccinated employees for Covid-19. The numbers that I have provided are your numbers that Chief Moore has given to the public. If you would like to double check the stated numbers and get back to me, please feel free to do so.

Last week the LAPD went from 14 to 13 "Long Covid Cases" per Chief Moore's briefing during the Police Commission meeting. Can you please define what Long Covid Cases means? Are you referring to an adverse event with the Covid-19 gene therapy shot or are you referring to what *the CDC Deputy Director Tom* Shimabukuro admitted to that Covid-19 vaccines are causing "Debilitating Illnesses" and "We are aware of these reports of people experiencing long-lasting health problems following Covid vaccination." I'm not requesting the names of the LAPD personnel, just a definition as to the meaning of "Long Covid Cases". The term "Long Covid Cases" has been used for the past several months and it's unclear.

There is mounting evidence that the CDC, WHO, FDA and the scientific community has repeatedly overstated the evidence and misled the public with their own views and policies as well as the City of Los Angeles. All of you have created a policy based on your preferences and justified it by manipulating data.

As I have mentioned in my previous public comments, I have three sources from the City of Los Angeles regarding your Covid-19 figures. All three of these sources do not remotely align with one another. *Chief Moore* in 2022 has stated on several occasions the vaccinated employees were making up 58% of the total infections, when at the time it was really 74%. To achieve 58%, you had to blend Covid-19 infections from June of 2021 with 2022 Covid-19 infections, which is not accurately showing the current trends. *Commission Briggs* used data from the L.A. County Health department that was several months old that did not align with the current trends to justify the extension of the state of emergency. Commissioner Briggs did this because at the time of his reporting the current Covid-19 numbers did not support extending the state of emergency. Commissioner Briggs solution was to go back and find data that did and misinform the public. This worked and it worked well, until both of you were caught red handed.

This is one of many reasons why the public does not have much faith or trust in our City Officials. I will offer a suggestion to all of you, you should all meet and have an open honest conversation with each other. I would begin with these three questions,

- What did the City of Los Angeles do right during the pandemic?
- What did the City of Los Angeles do wrong during the pandemic?
- Where could the City of Los Angeles have done better during the pandemic?

It's important that you are 100% upfront and honest with one another and yourself. Do not allow this to be politically driven and simply speak to facts. Mistakes are made every day, some are small, and some are rather large. No matter the size of the mistake, we must have the ability to accept and benefit and learn from these mistakes. Perhaps Mayor Bass can address the City of Los Angeles of the findings during this meeting.

As with all surveillance tools LAPD uses (and you continue to allow), Automated License Plate Readers (ALPR) cameras are used disproportionately towards black, brown, and poor communities. The pictures ALPR cameras take are then checked against "hot lists" and stored for years as part of LAPD's continued infringement of privacy rights, tracking, and stalking.

LAPD already invades citizens' privacy rights plenty enough with all of the data they track on especially Black, brown, and immigrant communities. LAPD already does this by sharing information with ICE through fusion centers (despite them in one BOPC erroneously saying they don't). Adding ALPRs will expand LAPD's massive surveillance system, thus expanding their systems of discrimination.

As is usual, LAPD's continues to gaslight concerned residents and tone down the expanse of what ALPR and LAPD's other technologies do. Though LAPD tries to portray plate scans as being non-controversial to collect as it is "information that is in the public view," this disregards what happens to that information, which is kept by LAPD for years and is accessible to other agencies as well. The information is also used for tracking a person and making predictions about where they will be, or go next. It is also used to create social maps, and to map the relationships a person has with other people (and their cars) in the area - or to make guesses or predictions about what those relationships may be.

Lastly, the system LAPD is *currently* using as an ALPR allows officers to convert smartphones into scanners for face scans and facial recognition. So now they aren't only scanning license plates but any person. People have to go into public you cannot say that "well we're gathering information that is in public" - it is sick and wrong that you're using that as an excuse to invade people's privacy rights, and then pump this grossly collected data into "predictive analyses" and use it to ensnare anyone LAPD doesn't like.

General Public Comment: Stop Limiting Public Comment

Remove the 45-minute time limit on public comment, thereby allowing every single person who calls in to be allowed to speak. Remove the two-time limitation on each individual's public comment. Allow community members to speak after every single agenda item, as opposed to continuing the patently ludicrous practice of forcing the public to speak before any of these items have been discussed. Inform the public who is up next to speak. Resume in-person meetings. In general, make every effort to remove procedural barriers and impediments to civic expression, and discontinue your visible displays of irritation with and hostility towards the public you purport to serve. Members of the communities most affected by policing are by far the most knowledgeable about the real-world effects of the matters before this board, and about LAPD in their neighborhoods, and you should be doing everything you can to make it easy for them to give public comment. Week after week, your actions belie your hollow claim to be the "citizen's voice in police affairs."
