The purpose of this Notice is to revise the Traffic Collision and Arrest Status Report, Form 04.16.00, and the Arrest Disposition Notification, Form 335. Revisions to these forms have been made to improve functionality and efficiency.

The following revisions have been made to the Traffic Collision and Arrest Status Report, Form 04.16.00:

- "IMP.?" has been revised to "IMPOUND?":
- "VICTIM'S NAME" has been revised to "PARTY NO. 2 OR VICTIM";
- "17(b)4 PC SUPV. NAME AND SERIAL #" has been revised to "17(B)4 PC SUPERVISOR NAME AND SERIAL No.";
- "V-1 DMV" has been revised to "V-1 INFORMATION FROM DMV";
- "LICENSE No." and "STATE" in one box has been revised to two separate boxes;
- The "DATE" column was removed;
- Under "DRIVER ID'D?" the "yes" and "no" boxes were removed and replaced with a drop down box on E-Forms but not on paper form;
- RD box was added;
- Check boxes were added to "CASE STATUS"; and,
- An additional blank line was added under "INVESTIGATING OFFICER(S) NAME(S) AND SERIAL No." and "DETAIL."

The following revisions have been made to the Arrest Disposition Notification, Form 335:

- "Temporary Form 335 (08/00)" has been revised to "Form 335 (02/2023)";
- "Supervisor Approving Arrest Report" line was moved to below the second "Arresting Officer" line;
- "Booking No." has been revised to "Booking No./DR No.";
- "Filed" has been revised to "Charges Filed?";
- A line was added to record the suspect/arrestee's "name" and "date of birth"; and,
- "This form shall be stapled to a copy of Form 05.10.00" has been revised to "This form is to be emailed to the arresting officers upon disposition of investigation."

The use, completion, and distribution of these forms remain the same.
