# LOS ANGELES POLICE DEPARTMENT MACTAC (Basic) 1850-20147 Expanded Course Outline

<u>Instructional Goal</u>: To review the student's basic skills in MACTAC principles and IARD tactics, to recognize potential indicators of a MACTAC incident, to demonstrate proficiency in the ability to immediately deploy as a contact team or squad with the capability to locate and neutralize violent assaults and/or terrorist acts. This course provides the student with the minimum topics of Use of Force and Strategic Communication required in the POST Perishable Skills Training Program.

<u>Performance Objectives</u>: Using group activities and discussions, drills and practical application scenarios, the student will:

- Demonstrate a working knowledge of MACTAC principles and IARD tactics through practical application scenarios
- Perform Contact Team Mission Tactics
- Demonstrate how to read and tactically respond to open air and interior terrains
- ☐ Know and understand how to utilize the four A's: Assess, Announce, Assemble and Act in field situations.
- □ Demonstrate basic TAC-MED care and tourniquet application
- Demonstrate an understanding of the Rescue Task Force mission, Rescue Team mission, deploying with Fire Department personnel, and establishing a Unified Command for purposes of rendering aid.
- Demonstrate an understanding of how our Department's guiding value of Reverence for Human Life as the moral and ethical foundation of de-escalation, tactics, reasonable force, and Officer safety.
