 - The box titled "VICTIM'S EXEMPLAR INCLUDED";
 - The box titled "AFIS"; and,
 - The box titled "CHEMICAL PROCESS."

The following information was added to the form:

- SERIAL NO. was added to the LATENT PRINT INVESTIGATOR BOX;
- FRICTION RIDGE ONLY was added above #LIFTS and #PHOTOS boxes; and,
- The box titled "OTHER EVID."

The use, completion, and distribution of this form remain unchanged.

II. LATENT PRINT BACKING CARD, FORM 05.21.00 - ACTIVATED.

- **A.** Use of Form. This form will be used by Technical Investigation Division to preserve and document latent print evidence collected in the field.
