To the Los Angeles Police Commission, Chief, All Officers and Citizens,

The Los Angeles City government and LAPD seem to not be concerned or have difficulty in distinguishing between LEGAL and ILLEGAL aliens or immigrants.

Police Commissioners,
LAPD officers do not ask the birthplace of victims and witnesses as is implied in the LAPD Role in Immigration Enforcement report. They also do not ask the immigration status of victims and witnesses. Some activists and others in the community for political reasons are fear-mongering and you should be very clear on this.

Removing the birthplace question from the field interview card that should be used when interviewing suspects can potentially hinder future investigations. There was no legitimate reason to remove that question. Instead, you are pandering to the "Immigrant community" lobby. Keep in mind that many criminals who have committed crimes in different states and in other countries around the world find their way to Los Angeles where they hope to disappear and blend in to avoid the law. Any bit of information on a field interview card can be vital to a detective working a case. Stop playing political games and word games. Put public safety above political pandering Public safety is at stake!
