LAPD also continues to take resources the community needs; over **\$3B** of the city budget goes to funding LAPD, an organization that contributes to community harm and crime. 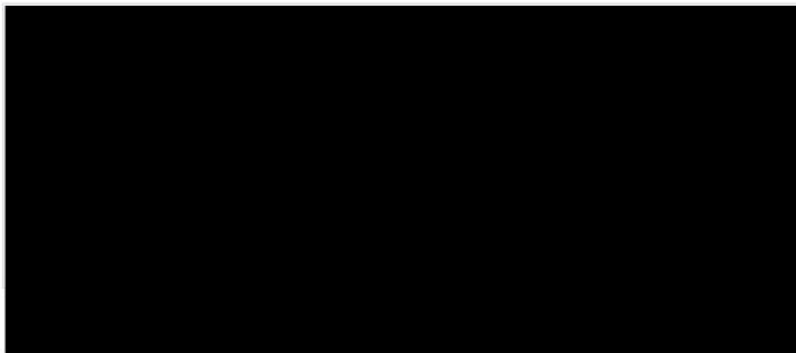

When LAPD released a "critical incident" video of the shooting, Captain Kelly Muniz states that Cua was shot after taking a gun from his waistband and "pointing it in the direction of the officers," but the body worn video [only shows Cua running away](#) right before he is shot, not raising a gun.

This is not the first time LAPD has lied either outright or through omission in its critical incident videos, such as in the shooting of [Jermaine Petit](#) and the killing of [Margarito Lopez](#). LAPD claims its edited videos are "an understanding of what occurred based on what we know right now" but they are conveyed as the official narrative. It is another damning example of how police outright lie and get away with it as they continue to kill people.

So far in 2023 LAPD has killed 4 people by fatally shooting them, a 5th person with a taser and bodily force, and a 6th person was found dead inside the Van Nuys jail. LAPD also continues to take resources the community needs; over \$3B of the city budget goes to funding LAPD, an organization that does not increase community safety or well-being, and does not prevent or solve what we call

crime - in fact, it only contributes to it. We demand a divestment from LAPD and an investment in communities! Fund communities, not the police!
