"Madam Mayor: May you be showered with His Peace & Blessings:

During public comment at Tuesday's May 7th, the Board of Police Commissioner meeting some speakers called for the removal of Commission President Dr. Erroll Southers accusing him, among other things, of Islamophobia.

I have known Commissioner Southers for nearly twenty years. I am familiar with his long years of service in various law enforcement agencies. I was one of his research resources while he was working on his phd dissertation. Since he joined USC we have been partners and colleagues representing our respective institutions.

Besides Omar Ibn Al Khattab Foundation Commissioner Southers enjoys respectful collaborations and cordial relationship with Muslim leadership and advocacy groups including MPAC. There is no evidence he harboured any bias, prejudice or hatred towards Muslims. To the contrary at the height of ISIS crisis his presentations, on panels at UCLA and in other locations in Los Angeles, were fair and balanced. The same can't be said of other presenters.

While we collectively support the right of others to free speech. Racism, Islamophopia, anti Semitism and bigotry are too serious to be expediently exploited to defame those whose views we oppose, to assassinate the character and reputation of those with whom we disagree or slander those who do not fit the narrative we wish to advance.

Similar to other Angelenos groups Muslims are not homogeneous in their opinions. There is no one group that can claim to represent or speak on behalf of Muslims. However, the Muslim community has credible organizations, institutions and advocacy groups whose views and positions are respected and supported within the mainstream Muslim community. Non of them were represented in the Commission meeting.

Combatting prevalent racism, islamophopia, anti Semitism and the eradicating of hate is the responsibility of all of us and not only a concern for the targeted community alone. However, it should not be hijacked or exploited by by opportunists to advance their agenda.

Your Honour appointed Commissioner Southers because of the integrity, expertise, wealth of experience and the standing in the law enforcement community he brings. This complements the diverse skills and credibility and the confidence Angelenos have in the Board of Police Commissioner you have carefully appointed.

The Board is currently engaged in the task of national search for the LAPD chief. This critical assignment should be clouded by uncertainty or speculation on future of the President of the Board.
