Board of Police Commissioners, Chief McDonnell, LAPD, and public,

On April 2, 2025 22 new recruits graduated from the Los Angeles Police Academy! Keeping in mind that the department goal is 60 recruit graduates per month to replace the many officers that are leaving the department for various reasons, 22 is an incredibly low number! Upon review of the recruit graduate class demographics provided by <u>LAPDONLINE.ORG</u>, we see that the graduating class by the LA City categorization by race is 18 Hispanic, 1 African-American, 1 Asian and 2 Caucasian listed in that order. And what order is that exactly? It's not alphabetical and it isn't by descending order of category from high to low. The time has come to ask what is going on with these abysmal hiring numbers, categorizations by race and their presentation with Caucasians always being listed last.

The category designations by race are counterproductive if we are striving to look beyond race and see people as individuals and not representatives of their collective race identity which is racial arbitrariness! Caucasians should not be identified as Caucasians any longer and should be designated as European-Americans if a category is really needed, which it is not. Upon review of the recent hiring trends, the hiring of European-Americans is inextricably extremely low. There has to be an explanation for that! What is it? It would appear that "Caucasians" are always put at the bottom of the list and very often are intentionally omitted from LAPD recruiting materials and content altogether. The message seems to be a replay of "No Irish Need Apply" expanded to "No Whites Need Apply".

Discrimination in hiring practices based on race is illegal. I call for an investigation into LAPD hiring practices on the basis of disparate impact on "European-American, Caucasian or "White" individuals who appear to be the victims of LA City discriminatory hiring practices. I call for the US. Civil Rights Division of the US Dept of Justice to investigate the matter because the LAPD and Los Angeles City are unable or unwilling to provide the information on recruitment numbers and processes in a complete, accurate, thorough, honest and public way. Another issue which I'm sure prospective LAPD candidates are looking at is the COVID-19 mandate policy and the way those who stood for their individual sovereignty and rights were cruelly, harshly and unfairly treated with no respect for their religious convictions or individual medical and health concerns. Any and all officers that suffered harm should be re-instated with back pay, an apology and choice of assignment in an attempt to undo the damage that was done to those officers and their families. New recruits should not be required to be Covid 19 vaccinated and their individual rights must be respected and publicly so.

When citizens need the police and call for police help and service they are entitled to a prompt response by professional police officers that represent the best of the police profession. It is the duty of the Los Angeles Police Commission and Mayor to set policies that will make that a reality. Higher standards will lead to higher recruitment numbers and lower standards will lead to lower recruitment numbers. A culture of excellence and integrity must be encouraged and Chief McDonnell can do that but the policies are set not by him , but by the Mayor, Police Commission and City Council! The people need the Police Commission to set policies that set up the LAPD for success and not failure! As goes the LAPD, so goes the City. If the LAPD fails in its mission to protect and serve and provide public safety, the city will continue to decline and that would be a disaster for everyone!
