Dear Board of Police Commissioners and City Council Members:

As a citizen of Los Angeles District 10 I'm writing to submit public comments to the LA Police Commission meeting. I'm also cc-ing the city council members since the commission continuously fails to hold LAPD accountable and continues to not heed the majority of public comments given.

## Agenda Item 4A: Air Support Division

Los Angeles' police and sheriff's departments have amassed among the largest helicopter units of any local law enforcement agencies in the world, costing city and county residents tens of millions of dollars each year for patrols that disproportionately hover over low income communities of color, according to government records. The helicopters have hovered for decades with little evidence of their necessity.

As one article says (and you can fact check the info provided therein: "The federal government itself has acknowledged that "historically, the debate regarding the benefits and costs of airborne policing has been void of rigorous evaluation and empirical data,' according to the National Institute of Justice's most recent review of law enforcement helicopter operations in 2012.

Nicholas Shapiro, a University of California, Los Angeles, professor who is currently studying the health and climate impacts of law enforcement helicopters in Southern California, said, 'There's just huge logical leaps' in the early studies.

Shapiro's research team identified fundamental problems with the crime predictions and comparisons underpinning the LAPD helicopter study, such as conflating increased arrests with prevented crime and comparing real crime rates to modeled predictions. The study's authors also excluded data from 1965, when the Watts riots occurred, because they acknowledged this data would skew their results."

LAPD already has an enormous helicopter crew, apparently a *plane*, and other surveillance tools and the department has a vast history of surveillancing Black, Indigenous, and other people of color. The amount of "air support" LAPD has and uses is ridiculous. My neighborhood is a safe neighborhood yet it is constantly being circled by loud noisy helicopters. It

is so interruptive, annoying, and disruptive, and the use of LAPD helicopters has interfered in interactions between police and civilians, causing more confusion and disruption. LAPD does not need as many helicopters as it has and doesn't need to be spending the amount it does to fuel and fly its helicopters that bring more disruption to neighborhoods than anything else.

## **General Public Comment: Divest from LAPD**

As a social worker studying and researching police, I've long been telling you that LAPD funds need to be divested. You as the Commission need to be creating alternatives to police in traffic stops and responding to mental health crises. I've studied alternatives to police in these capacities --- the academic research shows that they work, and all without police killing people.

You know the numbers - in 2022 US law enforcement killed at least 1,186 people, more than any other year on record. And LAPD is the police department that kills the most people in the country out of all law enforcement agencies. Police kill despite body camera and no matter the amount of trainings you give them. You are complicit in these murders - you continued to just approve everything LAPD wants. Soboroff, you say that people who believe that are uninformed and that there have been many 3-2 or 4-1 votes. What doesn't matter is the makeup of the votes, but their result -- and they always result in approving LAPD to do whatever it wants to do. You need to defund the police, take those funds, and reinvest in the community.
