I do not support the use of Microsoft Co-pilot AI by LAPD. Does the City or the LAPD police department even have an AI policy or any written documentation articulating the guardrails around the use of AI? I could not find one.

Moreover, why do so many employees need a license if this is only a "pilot"? Furthermore, there is no clear articulation of what this pilot entails - what will be tested, what this will and will not be used for, and what will be in the report *with requirement for community input* before deciding to extend the pilot or adopt the use of this software.

Given the well-documented dangers of AI, it is astounding that it would be used by the police. In fact, AI is a danger to public safety and it would be derelict to be deployed without assurances, safeguards or limitations on its use.

Please do not approve this pilot or the use of unregulated AI by law enforcement.
