





DEFINITION OF TERMS

STOP: A temporary detention where a person is not free to leave and is initiated by officer's own observations. A Pedestrian Stop is any instance where an officer performs a stop of a person who is not in a motor vehicle. A Motor Vehicle Stop is any instance where an officer directs a person operating a motor vehicle of any type to stop and the driver is detained for any length of time.

CALLS FOR SERVICE*: Any radio call generated by communications in response to a call from the public.

ARRESTS (ALL – LAPD ONLY): All arrests (felony, misdemeanor, release-from-custody) made by LAPD officers.

HOMICIDE: The willful (non-negligent) killing of one human being by another. FBI's UCR DEFINITION

AGGRAVATED ASSAULT: An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm. FBI's UCR DEFINITION

VICTIMS SHOT: Victim's body (any part) is penetrated by a bullet / projectile from a firearm.

VIOLENT CRIME: Volent crime is composed of four offenses: Criminal Homicide, Rape, Robbery, and Aggravated Assault. Violent crimes are defined in the UCR Program as those offenses which involve force or threat of force, FBI's UCR DEFINITION

PART I CRIME: Part I offense classification includes: Criminal Homicide, Rape, Robbery, Aggravated Assault, Burglary, Larceny-Theft (except motor vehicle theft) and Motor Vehicle Theft. FBI's UCR DEFINITION

ATTACKS ON P.O. (AGG & SIMPLE): ADW against a police officer (LAPD only) and Battery on a police officer (LAPD only). LAPD's CCAD CODE MANUAL

GUNS RECOVERED: Any gun recovered by LAPD personnel. Excludes guns turned in during the gun buyback program.

USE OF FORCE

TOTAL CATEGORICAL: All EXCEPT animal shootings and unintentional discharges.

OFFICER-INVOLVED SHOOTING: For the purpose of this report, any discharge of a firearm by an officer at a human being. Note: this excluded all unintentional and animal shootings

Hit: Those incidents in which an officer discharges his/her firearm and the bullet fired makes contact with a human being.

Non-Hit: Those incidents in which an officer discharges his/her firearm and the bullet fired misses the targeted person and no human being is struck by the bullet.

Fatal: Those incidents in which an officer discharges his/her firearm, the bullet(s) makes contact with a human being, and when at least one of those bullets discharged causes death.

USE OF FORCE Cont'd

SUSPECT WEAPONS:

Firearm: A weapon, such as a pistol, revolver, shotgun or rifle capable of firing a projectile using an explosive charge as a propellant.

Replica Firearm, Pellet Gun, Air Soft, etc.: Any instrument that resembles a real pistol or revolver, but does not fire bullets (toy, starter pistol, movie prop). Air soft guns are designed to be realistic replica firearms. They are a special type of air gun, that fire spherical projectiles of many different materials, including (but not limited to) plastic, and biodegradable material. Pellet gun/Pellet Rifle is an air gun (often called pellet gun or BB gun depending on the projectile) that propels projectiles by means of compressed air or other gas, in contrast to firearms, which use an explosive charge. The rifle and pistol (air rifle and air pistol) typically propel metallic projectiles, either pellets, or BBs. Certain types of air guns, usually rifles, may also propel arrows or darts with feathers.

Edged Weapon: Any weapon or instrument that has a sharpened edge for cutting, slicing, slashing or a sharpened point for stabbing, thrusting or puncturing, is an edged weapon. Common edged weapons include spears, maces, clubs, halberds, axes, forks, farm tools, picks and the endless variety of daggers, knives and swords.

Blunt Force Weapon: Any solid object that can be used as a weapon, which damages its target by applying direct mechanical force, and has no penetrating point or edge, or is wielded so that the point or edge is not the part of the weapon that inflicts the injury. Blunt instruments may be contrasted with edged weapons, which inflict injury by cutting or stabbing, or projectile weapons, where the projectiles, such as bullets, which are accelerated to a penetrating speed.

Blunt instruments typically inflict blunt force trauma, causing bruising, fractures and other internal bleeding. Depending on the parts of the body attacked, organs may be ruptured or otherwise damaged. Attacks with a blunt instrument may be fatal.

Disarming or Attempt to Disarm Officer: Those incidents where an officer perceives that a suspect is attempting to disarm the officer by reaching, or grabbing his/her firearm, or a firearm of another police officer.

Simulated Weapon: Those occasions when a person's physical movement or mannerism is done in such a way as to feign being both in possession of and engages in movement(s) consistent with the intent on using a deadly weapon (firearm, replica, edged, blunt, etc.).

Furtive Movement: Is a sudden movement reasonably consistent with arming themselves with a weapon and not reasonably consistent with anything else under the circumstances.

Other Deadly Weapons: Any weapon not described above that could cause serious bodily injury.

HOW WAS CONTACT INITIATED

Public Request

Calls for Service (Telephone or other technical means): Those requests for police service that are made via telephone, TTD, or other device and is usually processed through Communications Division.

Citizen/Public Flag Down (In Person): Those requests for police services that are made by a person(s) contacting an officer(s) directly, while in the field.

USE OF FORCE Cont'd

Officer Initiated

Vehicle Stop: Those incidents where officers use the emergency lights, or emergency lights and siren to stop a suspected traffic violator or the officers have reasonable suspicion to believe the suspect(s) to be stopped is involved in criminal activity and is either driving and or a passenger in a motor vehicle.

Pedestrian Stop: Those incidents where officers use the lights, or lights and siren, or make a command, or even a request, for a person to stop or converse. The officers should have reasonable suspicion to believe the suspect to be stopped is involved in criminal activity.

Note: This box will also capture any incident arising from a consensual encounter.

Pre-Planned (Arrest/Search Warrant, Special Ops, etc.): Those activities that were pre-planned, such as Search or Arrest Warrant service, a Task Force or any type of activity that requires an Operational Plan.

Off Duty: Those incidents where the officer(s) was off-duty and not conducting official Department business prior to the OIS.

Suspect Initiated (Ambush): An act or an instance so as to attack by surprise or lure Officers resulting in an OIS.

INJURIES

Officer: The officer(s) involved sustained an injury. (Number of incidents in which officer was injured, not total number of officers injured.)

Suspect (Non-Fatal Injury): The suspect(s) involved sustained an injury. (Number of incidents in which suspect was injured, not total number of suspects injured.)

SUSPECT'S CONDITION

Perceived Mental Illness: The officer(s) involved were given information or otherwise believed the suspect suffered from mental illness.

Perceived Under the Influence: The officer(s) involved were given information or otherwise believed the suspect was under the influence of alcohol and/or drugs.

Perceived Under the Influence (Both): The officer(s) involved were given information or otherwise believed the suspect suffered from mental illness and was also under the influence of alcohol and or drugs.

Perceived Homeless: The officer(s) involved were given information or otherwise believed the suspect was homeless.

Perceived Suicide by Cop: Those incidents where the suspect appeared to intentionally provoke officers into believing that he posed a deadly threat that resulted in an OIS.

NON-CATEGORICAL INCIDENTS

All NCUOF Incidents: Those reportable Use of Force incidents that are not deemed Categorical.

USE OF LESS-LETHAL FORCE

Taser: Those incidents that involved the use of the Taser.

Bean Bag: Those incidents that involved the use of the Bean Bag.

40mm: Those incidents that involved the use of the 40mm.

Two or more less-lethal (used): Those incidents that involved the use of two or more combination of Taser, Bean Bag Shotgun and/or 40 mm Launcher.
