Dear Members of the Los Angeles Police Commission,

Hello Sgt. Miller,

I wanted to touch base again since our last conversation and make sure everything will be set for this Thursday's event.

I understand that you are already very familiar with the crowd who has been harassing the Church for the last several months. I wanted to provide a bit more data for you, which we also want to make sure is passed on to the supervisor who will be there on Thursday (if it is someone other than you).

What we are expecting at the event would be along the lines of attempts to harass, film, follow and disrupt the guests. Several of this group also carry bullhorns, which they have been routinely using to disrupt religious services at our church locations. Several have been arrested for violence (battery, unlawful use of tear gas, and one instance involving a knife).

As data, there are now approximately 10 cases filed against them for violations of PC 302, which specifically relates to disrupting religious services/meetings. While this event is not a religious event, there is also PC 415 (disturbing the peace) and PC 403 (disturbing other gatherings) which would apply on Thursday. I am attaching all three here for reference.

Essentially we want to make sure you have all of the relevant information on what we are expecting and aiming to prevent, and make sure that whoever is assigned on the ground the day of the event is also tracking with this.

Please let me know if any other information is needed from this end. Thank you very much.

Los Angeles Police Commission,

Last week I logged in for the Police Commission Meeting via Zoom and as the meeting came on I immediately raised my hand at 9:29. Yet, for the second week in a row, I was not provided the ability to express my thoughts in public comment. I want the public and Police Commissioners to know that when the secretary says there are no more callers that I, and others have been waiting to speak. In the past, the Police Commission has stated that it would allow anyone who showed up to have an opportunity to speak during Item 2 Public comment. I again remind you that anyone who shows up in person, or via Zoom, should be given the opportunity to speak. That is only fair. Some people are not able to attend a meeting at 9:30 AM on a Tuesday or may have limitations due to health reasons. Let everyone be heard. It's the right thing to do!

I listened to Chief Randolph read his script entitled "Chiefs Report". Who writes that script? It has been said that the Mayors Office has to approve the script and many believe that is the case. Words matter and to call that mass lawlessness that occurred a peaceful 'Immigration Protest" is an intentional distortion of the reality of what happened. The mass lawlessness event would better be described as an Anti-ICE Protest for Illegal Alien Invaders. Immigrants who are LEGAL do not have to protest and are greatly appreciated that they came to America THE RIGHT WAY!

The report covered two days of mass lawlessness that included street takeovers, Freeway takeovers, false imprisonment of motorists trapped by protestors, vandalism, assault with projectiles, failure to disperse, etc. That is not a peaceful protest. Five police officers were reported injured. Less than lethal munitions were deployed. And how many arrests were made? Two? That speaks volumes.

Who was the Incident Commander and who was preventing the LAPD from taking decisive action to restore order? What was the role of Mayor Bass in this LAPD acquiescence to mass lawlessness? In contradiction to the LAPD Police Chief and Commission remarks that praised the "calm and restraint of the officers" who "Just stood there and took it" it is clear

that acts that endanger the community, officers and city are mostly tolerated. Anyone who doubts this can review the video provided, not by mainstream media, but by citizen media that provided direct on the street coverage at great risk to themselves.

Commissioner Calanche requested that Senior Lead Officers provide "Know your Rights" outreach sessions to the "immigrant community" via Zoom in "key" divisions. Calanche should realize that the community at large does not receive that type of service, monthly Zoom meetings, from Senior Lead Officers and many SLOs are not performing SLO duties because the department is so short on patrol officers. "Know your Rights' sessions can be provided by community groups. Calanche should resign from her position of Police Commissioner based on her clear misunderstanding of the LAPD and SLO functions. She has repeatedly demonstrated that she has little to no knowledge of the LAPD, its policies and operations.

The question must be asked once again "Who is running the show at the LAPD" and what is the Policy on dealing with Mass Lawlessness events? Why was the lawless mob that took over streets on Cesar Chavez Ave east of Alameda Ave in the "Tunnel" not arrested or cited at the very least? Why was the mob released in pairs with a Verbal warning? In that situation the verbal warning is as good as the paper it was written on and perceived as weakness by those involved and the overall public.

As an American citizen that supports the LAPD and rule of law I sincerely hope that President Trump and ICE Director Tom "Hero" Homan and his ICE agent heroes aka HOMAN'S HEROES are planning to defund any police agency which does not cooperate with Federal law and policies under the concept of subsidiarity and that ICE performs its duties in removing criminal aliens in Los Angeles who pose a threat to all of us.

Remember Jamiel Shaw Jr murdered by a criminal illegal alien and the family he left behind.
