



Concealed Carry Weapons License Terms of User Acknowledgement

As a CCW License Holder I agree to abide by the following conditions:

1. While in possession of a firearm, I will not consume, ingest, or be under the influence of alcohol or narcotics, including those prescribed by a doctor.
2. I will carry my issued CCW license on my person anytime I carry my firearm.
3. I will only carry those firearms listed on my CCW license.
4. I will notify the CCW unit ***in writing*** within three business days of an arrest or any time I am named as a subject in a restraining order.
5. I will notify the CCW unit ***in writing*** within ten business days of any change of address.
6. I will notify the CCW unit ***in writing*** within three business days if I am the subject of any law enforcement detention.
7. I will notify the CCW unit ***in writing*** within three business days of any incident involving my use of or display of a firearm.
8. I understand that I must abide by the statutory conditions and restrictions listed in Penal Code Section 26200, and that a breach of any of those conditions or restrictions may result in the revocation of my CCW license pursuant to Penal Code Section 26195(b)(1)(B).
9. I understand that if I become a "disqualified person" as defined in Penal Code Section 26202, that may result in the revocation of my CCW license under Section 26195(b)(1)(D).
10. I understand that violation of the above terms, applicable statutory conditions or restrictions, and/or other applicable statutory provisions or requirements, may result in the denial or revocation of my CCW license.
11. I will not possess a firearm while in any of the following sensitive locations, per Penal Code Section 26230(a), or under any of the following conditions, and it shall be considered a violation of this agreement and my responsibilities as a licensee, which will subject the revocation of my CCW license:
 - Bars and restaurants that serves alcohol (and related parking areas);
 - Playgrounds and youth centers (and adjacent streets and sidewalks);

- Parks, athletic areas, and athletic facilities (and adjacent streets and sidewalks);
- Most real property under the control of the Department of Parks and Recreation or Department of Fish and Game;
- Casinos and similar gambling establishments (and related parking areas);
- Stadiums and arenas (and related parking areas);
- Public libraries (and related parking areas);
- Amusement parks, zoos, and museums (and related parking areas);
- City, county, state or federal building where prohibited by law;
- School zones, preschools and childcare facilities;
- Colleges and universities;
- Court buildings and state and local government buildings;
- Police stations and facilities where prisoners are detained or housed;
- Airports, passenger vessel terminals or on an aircraft where prohibited by law;
- Polling places;
- Possession of any illegal equipment or attachments to a firearm or any other act, omission, or commission, deemed by the Chief to violate applicable law or regulations.
