Commanding Officer Announcements

Crime Report:

The Figueroa corridor is starting to heat up. We are seeing spikes in crime in that corridor. In response, we are going to have more enforcement in that area during the day and, of course, in the evening to try to prevent these crimes from progressing any further.

In addition, we did have a couple street vendors, taco vendors to be specific, who were robbed earlier this week of their funds and earnings.

There are a lot of individuals out here, opportunists, taking advantage of our citizens, who are minding their own business or trying to make a living for themselves. Obviously, the police cannot always be everywhere. As always, if you see any criminal activity, please dial 911 and report the incident so that officers can respond.
